Provision for write off of entire stock of Tk. 5,70,02,014 was made in the accounts during the year under audit of which appropriate authorization is yet to be obtained. We could not physically verify the stock as the management could not present the stock for our varification during the time of our audit. But detailed schedule of stock segregating good and damaged were produced to us.

3. Inter company current account:

Tk. 6,49,61,386 was given to Bangladesh Luggage Industries Ltd. from time to time since 2004 and Tk. 2,14,01,250 was taken from Doel Apparels Ltd. The operation of the former company was closed in 2002 and suffering from liquidity crisis.

4. Profit and Loss Account:

The company incurred huge loss consecutively since 2003-03. During the year company incurred loss Tk. 6,83,12,000. The loss includes mainly Depreciation and write off Tk. 6,55,22,033.”
