

Description of alleged violation of securities laws:

Pursuant to BSEC letter no. BSEC/Surveillance/2023-1111/289 dated July 13, 2023, the investigation team of DSE investigated the share trading of Khan Brothers PP Woven Bag Industries Limited (KBPPWBIL) for the period from 05.03.2023 to 13.07.2023 and prepared this report. The investigation committee submitted the investigation report to the Commission. The investigation team randomly examined the documents collected from different TREC holders of clients regarding share trading of Khan Brothers PP Woven Bag Industries Limited. From the investigation report it appears, among others, that:

Trends of closing price and trade volume OF 'KBPPWBIL' in public market



YCP of the shares of 'KBPPWBIL' as on 05.03.2023 was Tk. 9.90 and closing price of the same was Tk. 29.30 as on 13.07.2023. During this period from 05.03.2023 to 13.07.2023, price of the shares of 'KBPPWBIL' was increased by Tk. 19.40 which is approximately 196% higher compared to closing price as on 02.03.2023.

A. Trading of Beacon Group & associates: Observation-1:

After examining account opening forms and relevant documents, it is revealed that Beacon Group & associates maintains eight accounts with different depository participants while trading the shares of 'KBPPWBIL' for the period from 05.03.2023 to 13.07.2023. The details of the accounts are delineated as follows:

















As per DSE trade data, *Beacon Group & associates* bought 12,861,615 and sold 454,003 shares from both public and block market during the period from 05.03.2023 to 13.07.2023 with their 8 (eight) BO accounts. Within the investigation period, *Beacon Group & associates* collectively traded 6.88% shares of 'KBPPWBIL' of total trade volume and realized a capital gain of Tk. 1,181,333.72 from the trading of "KBPPWBIL" share during the investigation period. It is also mentionable that this group of clients had significant amount of unrealized gain of Tk. 41,043,415.68.

Findings-1:

As per section 17 of the Securities and Exchange Ordinance, 1969, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of including its purchase by others or depressing its price for the purpose of inducing its sale by others;"

It is evident that Beacon Group & associates was involved directly and indirectly in a series of transactions of shares of 'KBPPWBIL' with the aforesaid BO accounts in order to create the appearance of active trading and raising of price of the said share.

Contraventions:

It appears that Beacon Group & associates (BOID # 1203710073922456, 1205590054811592, 1203710064190682, 1601880075153283, 1203710046187231 & 1601880046187231) have violated the 1203710065562496,

> Section 17(e)(v) of the Securities and Exchange Ordinance, 1969 by directly and indirectly effecting a series of transactions of shares of 'KBPPWBIL' creating the appearance of active trading therein and raising price of the said share.

Observation-2:

As per ledger, instrument ledger and portfolio statement of Beacon Group & associates, collected from the respective Depository Participants, it was observed that they had collectively acquired more than 10% shares of 'KBPPWBIL' as on during the investigation period. Details are given below:
