From above table, it is very clear that I had invested a cumulative amount of about **Tk. 6.08** crore for the time period ranging from 6 months to 1 and half years. Where I have managed to earn only **Tk. 87.77 lac** which is, approximately **13.82%** return on my investment. If anyone considers the effect of inflation, the return would be of about **8.34%** which is less than my cost



EXPLANATION AGAINST THE ALLEGED VIOLATION OF SECTION 17(e) (v): Why I traded the shares of Legacy footwear?

I had been following the shares of legacy since May 2018. However, due to shortage of fund and huge unrealized loss in my portfolio against stocks such as--- Peninsula, BSRM, Alif manufacturing company ltd., C & A Textiles Limited hindered me to transact the share. The volume and price was so significantly attracting under all technical signs that I could resist myself to frequently transact the stock. This is to be mentioned here that all the fundamentally sound stocks, such as-- GP, Squarpharma, Olympic etc. were performing so disappointingly that I had to think differently to protect the fund of my business. Thereafter, I followed the market pattern and transacted the share based on my trading capacity maintaining full compliance of the regulators. I neither purchased a single stock aggressively nor did I break any trading norms.

The price and volume movement of LEGACYFOOT is presented as under for kind reference

- 1. It could be noticed that I have traded only about 7.13% shares of Legacy (Being unaware of total volume in advance) out of the total volume at DSE which is not very significant to influence the trade of any particular stock.
- 2. I traded the stock on good faith without any intention to induce its price. As reported by you, my buy percentage on that stock during period under report was only 7.13%, which I believe, was not all significant compared to my investment size.

- 4. I reiterate my humble submission that during transaction, I never concentrated on making big volumes to manipulate price. Moreover, it is quite impossible to know the total volume at the beginning of a trading day. To the best of my knowledge, there is no specific rule that limits a client to trade certain percentage of volume in any particular stock on a single trading day.
- 5. It may also be observed that the trend for the stocks under investigation started much earlier but I could not avail the opportunity of caching of an uptrend of the share. It is known to every stock market participant that catching the beginning of a trend gives an investor to earn more profit. And the analysis suggests that there was an uptrend in terms of price and volume of the reported stock.
- 6. During the reported transaction period, I have bought 7,81,946 no. of shares against sale of 6,58,147 no. of shares of LEGACYFOOT, indicating that it was not a one way traffic, I have periodically took the netting facilities in an attempt to earn some profit, which I believe, is permissible by securities law.

The above analysis signifies that the prices of the LEGACYFOOT increased without my significant participation. I traded that share thinking that I could make up for some of my previous losses.

However, I humbly submit that I have not acted contrary to Section 17 (e) (v) of the SEC Ordinance, 1969.

Therefore, we humbly request you to kindly accept my explanation and withdraw allegations of being in violation of Section 17 (e) (v) of the SEC Ordinance, 1969."
