In the above referred letter, BSEC has provided trade description of share transaction of Monno Ceramic Industries Ltd. from 22/08/2017 to 04/09/2017 and Legacy footwear Ltd. from 20/05/2018 to 03/06/2018, BDAUTO CAR Ltd. from 05/06/2018 to 11/06/2018 and Queensouth Textiles Ltd. from 23/04/2018 to 06/05/2018. Therefore, we (BO ID: 120300000100724 and 1203000062459368) have been accused of being directly involved in a series of transaction in the shares of the aforementioned companies.

Therefore, I would like to afford the following response to the above mentioned findings.

Before my explanation, I would like to draw your kind attention to my investment in capital market for the reported BO IDs:

Sir, I am a banker by profession. I have invested in capital market with the hope to earn some money for my future safety. Way back in 2010, I opened a BO account with Commerce Bank Securities and Investment Ltd. taking margin loan under the loan ratio 1:1. My total deposit was about Tk. 1.02 crore. For long 7.2 years, I tried my heart out but failed to earn any return and could not withdraw a single taka from my account. Loss, Loss and only Loss was the story of my stock market journey. Later on 02/01/2017, I insisted my wife to open another BO Account just to try her luck. To my wonder, she became a gainer right away. However, my loss in stock market is dominating. As you can see that I still suffering by a capital loss of Tk. 71.17 lac. I collected those funds from bank loan, taking loans from relatives and friends and own savings. For such long period I received nothing but humiliation and indignation of the people.

If you kindly glance through the above table, you find that I already incurred capital loss totaling Tk. 71.17 lac out of my total capital of Tk. 1.38 crore, being 51.55% loss.

### **Explanation of alleged manipulative transactions:**

My buy volume vis-a-vis DSE total volume in the reported stocks are as under:

As you glance through, you find that our total traded volume was very insignificant to the total traded volume of the reported stocks at DSE. Our highest traded percentage of 4.36% at Legacy footwear Ltd. was not at all significant commensurate with my investment size. On the other hand, we have literally traded very trivial quantity in others stocks which we believe did neither abuse the price nor the total volume of the stocks under investigation.

We request you to kindly consider our matter with sympathy and.”


