Subject: Warning: Non-compliance with Section 18 of the Securities and Exchange Ordinance, 1969 in connection with Fixed Asset schedule

Dear Sir,

This refers to BSEC's show cause-cum-hearing notice no. SEC/Enforcement/2169/2014/150 dated April 11, 2018 and the accused's explanation letter no. KBPPWBIL/BSEC/2018/13 dated April 16, 2018 submitted to the Commission.

Since any incorrect figure in the financial statement of a company may mislead the stakeholders in decision making relating to that Company, so the accused's explanation in this connection is not acceptable to the Commission. However considering the company's subsequent rectification and publication of corrigendum the Commission has decided to dispose off the proceedings against the accused by placing on record the Commission's dissatisfaction on the defaults/contraventions made by them with a warning to ensure compliance of all securities related laws in future.

This disposal does not absolve Khan brothers PP woven Bag Industries Limited, its directors, managing director and company secretary from their lawful responsibilities/obligations to any person, if affected as a result of the aforesaid default.
