যেহেতু, Securities and Exchange Ordinance, 1969 এর Section 2 (cc) মোতাবেক কমিশন অর্থ বাংলাদেশ সিকিউরিটিজ অ্যান্ড এক্সচেঞ্জ কমিশন যা বাংলাদেশ সিকিউরিজি অ্যান্ড এক্সচেঞ্জ কমিশন আইন, ১৯৯৩-এর অধীনে গঠিত:

যেহেতু, আগস্ট ২১, ২০১৯ তারিখের Surveillance Note-054/2019 অনুযায়ী এবং Regulation 16(3)(c)(ii) and (d)(v) of Dhaka Stock Exchange (Board and Administration) Regulations, 2013 দ্বারা প্রদত্ত ক্ষমতাবলে ঢাকা স্টক এক্সচেঞ্জ লিমিটেড ০১.০৮.২০১৯ থেকে ২১.০৮.২০১৯ পর্যন্ত সময়ের জন্য GLOBAL INSURANCE COMPANY LTD. (GLOBALINS) -এর শেয়ার লেনদেন সংক্রান্ত ইনভেন্টিগেশন কার্যক্রম পরিচালনা করেছে এবং কমিশনে এ সংক্রান্ত প্রতিবেদন দাখিল করেছে। ইনভেন্টিগেশন প্রতিবেদন থেকে অন্যান্যের মধ্যে নিয়লিখিত বিষয়গুলি উপস্থাপিত হয়:

#### A. Mr. Md. Louthful Goni Tito:

#### Observation:

It has been found that Md. Louthful Goni Tito and his associate (spouse) maintains three (03) BO accounts; one is by his own name (client code: # J1262 of Multi Securities & Services Limited), one is by his spouse Shammi Neawaz (client code: # J1263 of Multi Securities & Services Limited) where he is nominee and the last one is Shatrong Agro Fisheries Limited (client code: # 43305 of EBL Securities Ltd.) where Md. Louthful Goni Tito is the managing director. Through these three (03) BO accounts, 45,155 "GLOBALINS" shares were traded among each other during the investigation period.

After analyzing documents, it is observed that Shatrong Agro Fisheries Limited (Client code # 43305 of EBL Securities Ltd.) was the top buyer of "GLOBALINS" share from 01.08.2019 to 21.08.2019. The said client alone traded 35.75% shares of "GLOBALINS" compared to the total traded shares during the period. The 4<sup>th</sup> buyer Md. Louthful Goni Tito (Client code # J1262 of Multi Securities & Services Limited) is the Managing director of Shatrong Agro Fisheries Limited (Client code # 43305 of EBL Securities Ltd.). It is also found that the 6<sup>th</sup> buyer Shammi Neawaz (Client code # J1263 of Multi Securities & Services Limited) is spouse of Md. Louthful Goni Tito. They (Md. Louthful Goni Tito and Shammi Neawaz) are the nominees for each other BO accounts. In the sense Md. Louthful Goni Tito and his associate (spouse) maintained three (03) BO accounts where they collectively traded 54.39% of total trade volume during the period.

After analyzing documents, it is observed that Shatrong Agro Fisheries Limited (Client code # 43305 of EBL Securities Ltd.) was the top seller of "GLOBALINS" shares from 01.08.2019 to 21.08.2019. The said client alone traded 35.75% shares of "GLOBALINS" compared to the total traded shares during the period. The 2<sup>nd</sup> seller Md. Louthful Goni Tito (Client code # J1262 of Multi Securities & Services Limited) is the Managing director of Shatrong Agro Fisheries Limited (Client code # 43305 of EBL Securities Ltd.). It is also found that the 3<sup>rd</sup> seller Mrs. Shammi Neawaz (Client code # J1263 of Multi Securities & Services Limited) is spouse of Md. Louthful Goni Tito. They (Md. Louthful Goni Tito and Shammi Neawaz) are the nominees for each other BO accounts. So, it is evidently found that the top three (03) sellers of "GLOBALINS" shares are related to each other. In that sense, Md. Louthful Goni Tito and his associate (spouse) maintained three (03) BO accounts through which they collectively traded 54.39% of total trade volume during the period.

Md. Louthful Goni Tito (Client code # J1262 of Multi Securities & Services Limited) was one of the top trader of GLOBALINS shares during the investigation period. After examining account opening forms and relevant documents, it is revealed that *Md. Louthful Goni Tito* was involved with three (03) BO accounts directly or indirectly. Details of the accounts are given below:

However, it is evident that Md. Louthful Goni Tito and his associate (spouse) maintains thee (03) BO accounts; one is by his own name, another is by his spouse Shammi Neawaz where he is nominee and the last one is Shatrong Agro Fisheries Limited where Md. Louthful Goni Tito is the managing director.

As per DSE trade data, *Md. Louthful Goni Tito* and his associate (spouse) bought 3,066,092 shares and sold 4,400,514 shares of "GLOBALINS" during the period from 01.08.2019 to 21.08.2019 through their BO accounts with EBL Securities Ltd. and Multi Securities & Services Limited. They collectively traded 54.39% of total trade volume and realized a capital gain of Tk. 10,136,456.78 from the trading of "GLOBALINS" share during the period from 01.08.2019 to 21.08.2019.

It is also observed that Mr. Md. Louthful Goni Tito and his associate (spouse) (Client Code: # J1262, #J1263 and # 43305) were involved in trading of "GLOBALINS" shares by those three (03) accounts which resulted no change in beneficial ownership and misleading appearance of active trading on different date(s) with EBL Securities Ltd. and Multi Securities & Services Limited. As a result, 45,155 shares of "GLOBALINS" were executed in 31 howla(s) where the related account holders acted as both buyer and seller as shown below:
