Trends of closing Price and trade volume of "NFML" in public Market.

YCP of NFML as on 11.04.2021 was Tk. 15.60 and closing price of the same was Tk. 36.50 as on 17.05.2021. During this period the investigation team found that the price of NFML share was increased by Tk. 20.90 which is approximately 133.97% higher compared to YCP of 11.04.2021.

Paramount Insurance Company Limited and its associates:



After scrutinizing the Trade monitoring screenshots collected from Surveillance Department, it is found that *Paramount Insurance Company Limited and its associates* were involved in trading of shares of NFML which influenced price of the said shares on several dates:




It was observed in the above graph that on 25.04.2021, total number of trades of NFML in the market was 714 whereas number of trades executed by *Paramount Insurance Company Limited and its associates* was 236which is approximately 33.1% of the total number of trades in the market. Again, total traded volume of NFML share in the market on that day was 2,721,444 whereas buy volume by the said clients was 1,148,960 shares which is approximately 42.2% of the total traded volume in the market. It is evident that the clients had significant participation in the market on 25.04.2021 in trading of NFML share.

On 25.04.2021, trading of NFML share was started at Tk. 19.3 which is Tk. 0.6 more than the YCP of Tk. 18.7. On that day, *Paramount Insurance Company Limited and its associates* started series of trading at 10:12:16 at price Tk. 19.9 and induced the same to rise to Tk. 20.4 up to 10:17:42. After the price of NFML share being halted at Tk. 20.5 at 10:17:46, *Paramount Insurance Company Limited and its associates* continued trading of NFML share at halted price of Tk. 20.5 up to 12:11:16. It can also be observed from the above graph that the said clients executed significant trades during this time period. It is mentionable here that from 10:12:16 to 12:11:16, *Paramount Insurance Company Limited and its associates* bought 1,148,960 shares of NFML compared to the total traded share of 1,539,695. This is shown in the following Pie Chart.



It is also found that during the aforementioned period, *Paramount Insurance Company Limited and its associates* executed 236howlas to purchase of shares of NFML compared to the total number of howlas of 342 as shown in the following Bar Chart.








It was observed in the above graph that on 04.05.2021, total number of trades of NFML in the market was 2,306 whereas number of trades executed by *Paramount Insurance Company Limited and its associates* was 269which is approximately 11.7% of the total number of trades in the market. Again, total traded volume of NFML share in the market on that day was 10,024,697 whereas buy volume by the said clients was 2,000,000 shares which is approximately 20.0% of the total traded volume in the market. It is evident that the clients had active participation in the market on 04.05.2021 in trading of NFML share.

On 04.05.2021, trading of NFML share was started at Tk. 25.9 which is Tk. 0.1 more than the YCP of Tk. 25.8. On that day, *Paramount Insurance Company Limited and its associates* started series of trading at 11:27:23 at price Tk. 26.8 and induced the same to rise to Tk. 27.7 up to 11:31:52.It can also be observed from the above graph that the said clients executed significant trades during this time period. 






It was observed in the above graph that on 06.05.2021, total number of trades of NFML in the market was 2,339 whereas number of trades executed by *Paramount Insurance Company Limited and its associates* was 363which is approximately 15.5% of the total number of trades in the market. Again, total traded volume of NFML share in the market on that day was 13,082,581 whereas buy volume by the said clients was 2,710,000 shares which is approximately 20.7% of the total traded volume in the market. It is evident that the clients had active participation in the market on 06.05.2021 in trading of NFML share.

On 06.05.2021, trading of NFML share was started at Tk. 30.9 which is Tk. 0.7 more than the YCP of Tk. 30.2. As per DSE trade data, *Paramount Insurance Company Limited and its associates* bought 19,806,846shares and sold 19,824,866 shares of NFML during the period from 11.04.2021 to 17.05.2021 through their BO accounts with City Brokerage Limited, IDLC Securities Limited and United Financial Trading Company Limited. They collectively traded 19.70% of total trade volume and realized a capital gain of Tk. 42,002,123.34 from the trading of NFML share during the aforesaid period.

<u>Findings</u>: It seems to us that *Paramount Insurance Company Limited and its associates* executed series of transactions through the aforesaid BO accounts creating the appearance of active trading therein and also influencing the price of NFML.

<u>Contraventions</u>: As per Section 17(e)(v) of the Securities and Exchange Ordinance, 1969, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of inducing its purchase by others or depressing its price for the purpose of inducing its sale by others;"

It is observed that the said clients were involved directly and indirectly in a series of transaction of share of NFML in order to create the appearance of active trading of the said share.

It appears that *Paramount Insurance Company Limited* (BOID # 1605170071960776) and its associates violated Section 17(e)(v) of Securities and Exchange Ordinance, 1969 by directly or indirectly executing series of transactions in the shares of NFML creating the appearance of active trading therein.

যেহেতু, Mohammad Jahidul Abedin-এর উপরোক্ত কর্মকান্ডের ফলে Section 17 (e) (v) of the Securities and Exchange Ordinance, 1969 লংঘন করেছে, যা সিকিউরিটিজ আইনের পরিপন্থী;

যেহেতু, Mohammad Jahidul Abedin-এর উপরোক্ত কর্মকান্ড Securities and Exchange Ordinance, 1969 এর Section 22 অনুযায়ী শান্তিযোগ্য অপরাধ;

যেহেতু, কমিশনের বিবেচনায়, সিকিউরিটিজ আইন ও বিধি-বিধান পরিপালনে আলোচ্য ব্যর্থতার জন্য, পুঁজিবাজারের শৃংখলা, স্বচ্ছতা এবং জনস্বার্থে আলোচ্য Mohammad Jahidul Abedin-কে জরিমানা করা প্রয়োজন ও সমীচীন;
