Her husband Mr. Md. Abul Khayer (Client code # ABM645 of Agrani Equity & Investment Limited, the 2<sup>nd</sup> top buyer and Client code # 7647 of UCB Stock Brokerage Limited, the 12<sup>th</sup> top buyer and Client code # 1689 of NRBC Bank Securities Limited) participated in trading of shares of "ONEBANKLTD" in association with the following account holders from 15.11.2021 to 30.11.2021:
  - His father and 3<sup>rd</sup> & 5<sup>th</sup> top buyer named Mr. Abul Kalam Matber (client code # 9166 of UCB Stock Brokerage Ltd and ABM663 of Agrani Equity & Investment Ltd);
  - Sister of Mr. Md. Abul Khayer, named Konika Afroze (client code # 7677 of UCB Stock Brokerage Limited and 03900 of NBL Securities Limited);

#### Findings:

After analyzing documents, it is observed that **Ms. Kazi Sadia Hasan** (Client code # 3898 of UCB Stock Brokerage Limited) was the top seller of shares of "ONEBANKLTD" from 15.11.2021 to 30.11.2021. The said client bought 39,829,936 and sold 23,356,110 shares of "ONEBANKLTD" during the aforementioned investigation period, which is 13.64% of total traded share of "ONEBANKLTD" during the period.

It is mentionable here that **Ms. Kazi Sadia Hasan** is the wife of **Mr. Abul Khayer** who participated in trading of shares of "ONEBANKLTD" in association with 13(Thirteen) more account holders (i.e. father, brother, sister and wife etc.) related to him and collectively traded significant portion of trades (47.07%) of the same company during the aforesaid investigation period.

### A. Trading of Mr. Abul Kalam Matber and his associates:

#### Observation(s)-1:

Mr. Md. Abul Khayer (client code # ABM645 & BOID # 1605110071091116 of Agrani Equity & Investment Limited) was the 2<sup>nd</sup> top buyer of the shares of "ONEBANKLTD" from 15.11.2021 to 30.11.2021. After examining the relevant documents, it was also observed that the said client participated in trading of shares of "ONEBANKLTD" in association with 13(Thirteen) account holders more in the name of his family members and institutions and the details of the same is delineated as follows:



The Investigation Team of IED collected Trade monitoring screenshots from the Surveillance Department of DSE on some trading date(s) where appearance of active trading of Mr. Abul Kalam Matber and his associates were observed which influenced to uplift the price of shares of 'ONEBANKLTD' during the investigation period.


The details of the graphs are given below:



A Green triangle represents trade of 'ONEBANKLTD' by Mr. Abul Kalam Matber and his associates

White triangle represents trade of shares of 'ONEBANKLTD' by other clients

After scrutinizing the Trade monitoring screenshots collected from Surveillance Department of DSE, it is found that Mr. Abul Kalam Matber and his associates were involved in trading of shares of 'ONEBANKLTD' which influenced to uplift the price of the said securities on several dates:



It was observed in the above graph that on 18-11-2021, total number of trades of shares of 'ONEBANKLTD' in the market was 1,672, whereas number of trades (buy) executed by Mr. Abul Kalam Matber and his associates were 746 which is approximately 44.6% of the total number of trades in the market. Again, total volume of shares of 'ONEBANKLTD' in the market on that day was 31,522,546 whereas, buy volume by the said clients was 22,306,550 which is approximately 70.8% of the total volume in the market. It is evident that the client had significant participation in the market on 18-11-2021 in trading of shares of 'ONEBANKLTD'.







On 18-11-2021, trading of ONEBANKLTD share was started at Tk. 13.40 which is Tk. 0.00 which is similar as the the YCP of Tk. 13.40. On that day, Mr. Abul Kalam Matber and his associates started series of trading at 13:43:47 at price Tk. 13.40 and induced the same to rise to Tk. 14.70 up to 13:53:02. It can also be observed from the above graph that Mr. Abul Kalam Matber and his associates executed significant trades during this time period. It is mentionable here that from 13:43:47 to 13:53:02, Mr. Abul Kalam Matber and his associates bought 21,928,919 shares of ONEBANKLTD compared to the total traded share of 26,168,907. This is shown in the following Pie Chart:



It is also found that during the aforementioned period, Mr. Abul Kalam Mather and his associates executed 700 howlas to purchase of shares of ONEBANKLTD compared to the total number of howlas of 831 as shown in the following Bar Chart:



It is observed from the above graphs and screenshot that Mr. Abul Kalam Matber and his associates bought 83.80% of the total trades of ONEBANKLTD shares by executing 700 of total 831 howlas from 13:43:47 to 13:53:02 on 18-11-2021. From 13:43:47 to 13:53:02, Mr. Abul Kalam Matber and his associates induced the price to rise from Tk. 13.40 to Tk. 14.70. Thus it seems that Mr. Abul Kalam Matber and his associates were actively trying to lift the price of ONEBANKLTD share. At the end of the day price of ONEBANKLTD share was increased by Tk. 1.30 which is approximately 9.70% higher than YCP.



It was observed in the graph dated 22-11-2021 that, total number of trades of shares of 'ONEBANKLTD' in the market was 7,565 whereas, number of trades (buy) executed by Mr. Abul Kalam Matber and his associates were 1,910 which is approximately 25.2% of the total number of trades in the market. Again, total volume of 'ONEBANKLTD' in the market on that day was 82,677,332 whereas, buy volume by the said clients was 35,031,755 which is approximately 42.4% of the total volume in the market. It is evident that the client had significant participation in the market on 22-11-2021 in trading of shares of 'ONEBANKLTD'.

On 22-11-2021, trading of ONEBANKLTD share was started at Tk. 16.10 which is Tk. 0.00 which is similar as the the YCP of Tk. 16.10. On that day, Mr. Abul Kalam Matber and his associates started series of trading at 10:01:00 at price Tk. 16.00 and induced the same to rise to Tk. 17.70 up to 10:05:59. It can also be observed from the above graph that Mr. Abul Kalam Matber and his associates executed significant trades during this time period. It is mentionable here that from 10:01:00 to 10:05:59, Mr. Abul Kalam Matber and his associates bought 19,990,695 shares of ONEBANKLTD compared to the total traded share of 23,201,896. This is shown in the following Pie Chart



It is also found that during the aforementioned period, Mr. Abul Kalam Mather and his associates executed 920 howlas to purchase of shares of ONEBANKLTD compared to the total number of howlas of 1,267 as shown in the following Bar Chart:



It is observed from the above graphs and screenshot that Mr. Abul Kalam Matber and his associates bought 86.16% of the total trades of ONEBANKLTD shares by executing 920 of total 1,267 howlas from 10:01:00 to 10:05:59 on 22-11-2021. From 10:01:00 to 10:05:59, Mr. Abul Kalam Matber and his associates induced the price to rise from Tk. 16.00 to Tk. 17.70. Thus it seems that Mr. Abul Kalam Matber and his associates were actively trying to lift the price of ONEBANKLTD share. At the end of the day price of ONEBANKLTD share was increased by Tk. 1.10 which is approximately 6.83% higher than YCP.

Again, on 22-11-2021, Mr. Abul Kalam Matber and his associates started series of trading at 10:20:46 at price Tk. 16.60 and induced the same to rise to Tk. 17.70 up to 10:28:23. It can also be observed from the above graph that Mr. Abul Kalam Matber and his associates executed significant trades during this time period. It is mentionable here that from 10:20:46 to 10:28:23, Mr. Abul Kalam Matber and his associates bought 9,799,968 shares of ONEBANKLTD compared to the total traded share of 13,963,638. This is shown in the following Pie Chart:













We analyzed, summarized and taken decision to invest in the mentioned share of ONEBANKLTD considering the development of Banking Sector. We have no other intention but to invest honestly in the mentioned shares like any other shares to get capital gain.

Please be noted that it gives huge losses in our portfolios although report mentioned in your letter shows significant realized and unrealized income.

We have given fresh buy and sale order to our traders to buy the shares in fresh without considering any bad or manipulative motive. Since we are maintaining a large number of portfolios in different houses, our simultaneous trading orders were passed to the traders for execution of trades. Thus, if any mistakes that may happened in our trades were purely unintentional or inadvertent mistakes which are evident in quantity of trades in comparison to total trades as per your report

I always try to comply rules and regulation at the time trade. In addition to this, my trade volume helps to provide sufficient liquidity in the market which ultimately increase the turnover of the exchanges.

I sincerely apologize for the inadvertent mistakes/ contravention that had happened through the abovementioned trades. It has happened due to my ignorance of the fact not intentional. I am assuring that I will be more careful for future transaction."
