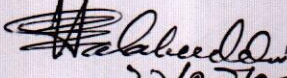

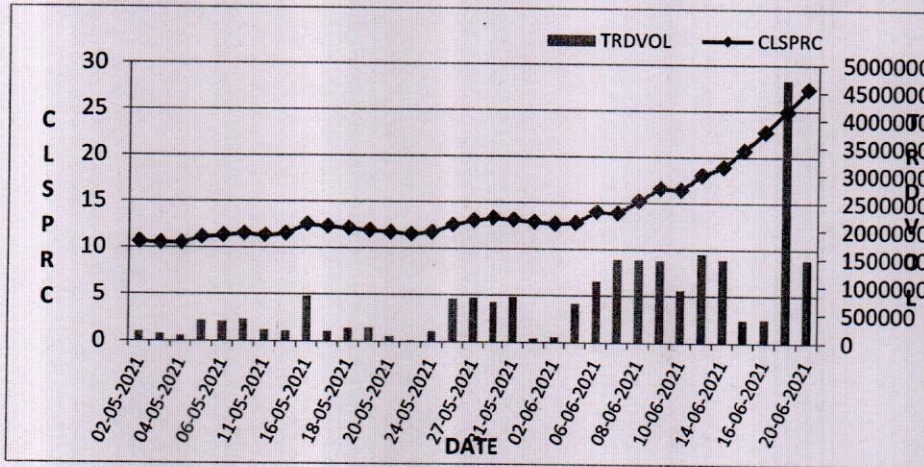

TRENDS OF CLOSING PRICE AND TRADE VOLUME OF "SAFKOSPINN" IN PUBLIC MARKET



YCP of SAFKOSPINN share as on 02.05.2021 was Tk. 9.70 and closing price of the same was Tk. 27.30 as on 20.06.2021. During this period from 02.05.2021 to 20.06.2021, price of SAFKOSPINN shares was increased by Tk. 17.60 which is approximately 181.44% higher compared to closing price of 29.04.2021.

A. Trade details of Mr. Md. Sajib Hossain and his associates:

Observation-1:

Mr. Md. Sajib Hossain was one of the top buyers of "SAFKOSPINN" share for the period from 02.05.2021 to 20.06.2021. After examining the relevant documents, it was found that the said client is associated with twenty-two accounts from which he and his associates traded shares of SAFKOSPINN during the investigation period. 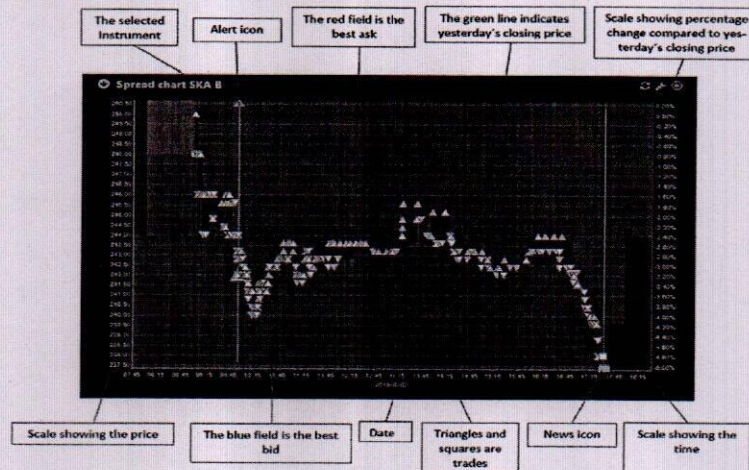

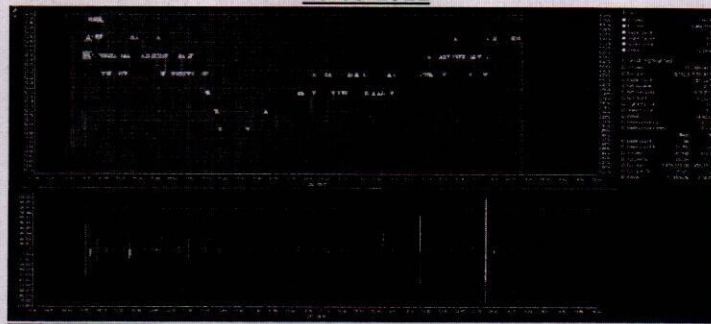


▲ Green triangle represents trade of **SAFKOSPINN** by Md. Sajib Hossain and his associates

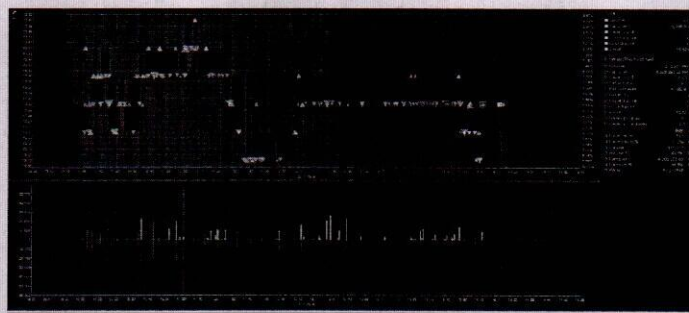

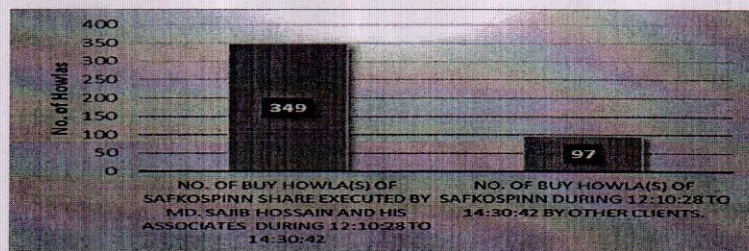

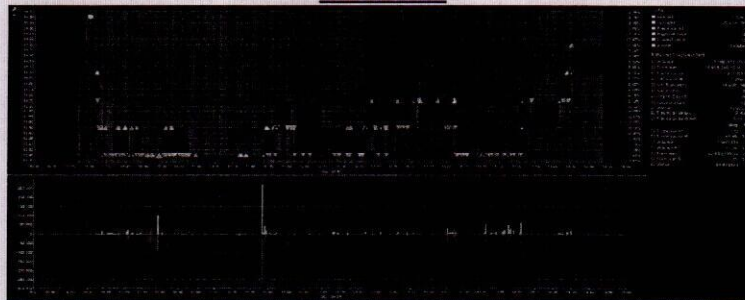

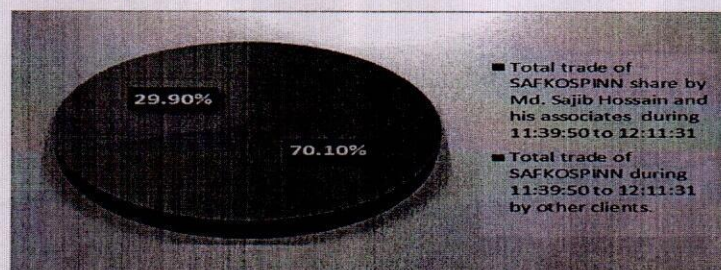

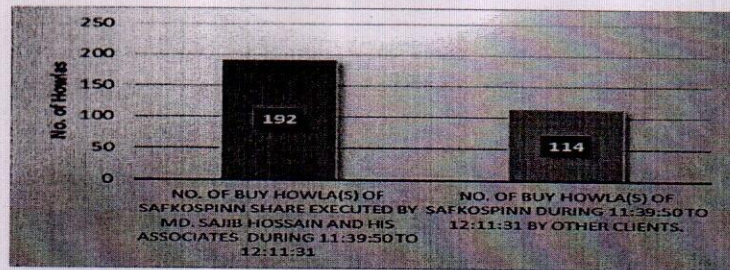

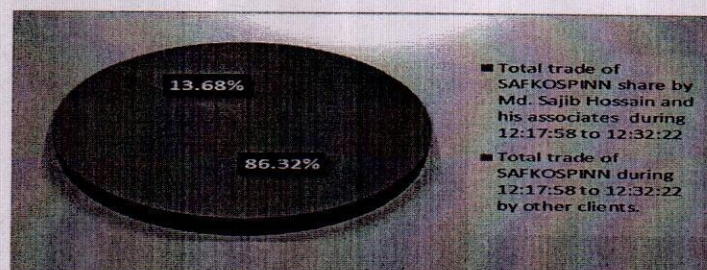

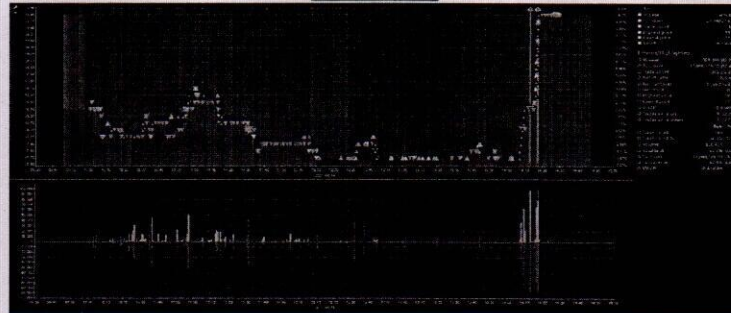

Sajib Hossain and his associates bought 6,711,268 shares and sold 7,138,487 shares of "SAFKOSPINN" from public market during the period from 02.05.2021 to 20.06.2021. With the said twenty-two BO accounts, Md. Sajib Hossain and his associates traded 45.53% shares of "SAFKOSPINN" during the investigation period and realized a capital gain of Tk. 38,211,002.11 from the trading of "SAFKOSPINN" share during the investigation period. He also had unrealized gain of TK. 35,229,794.92 during the period.

Findings- 1:

As per **section 17 of the Securities and Exchange Ordinance, 1969**, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

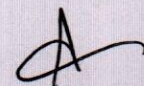

Observation-2:

After analyzing the trade pattern of the clients, the investigation team found that two clients named Md. Sajib Hossain (Client Code # 3828) of AIBL Capital Market Services Ltd. and Mr. MD. ABDUL QUDDUS AMIN (client code 1023) of Prime Islami Securities Limited were involved in trading in shares of "SAFKOSPINN" within the investigation period and these accounts are acting as counter party of each other for 60,091 shares of "SAFKOSPINN" on 25-05-2021 in 12 howlas in the public market.

It was also found that Md. Sajib Hossain (Client Code # M4993 of BRAC EPL Stock Brokerage Limited and Client Code # 3828 of AIBL Capital Market Services Ltd.) and MD. SULEAMAN (client code 10225 of Meghna Bank Securities Limited) acted as counter party of each other for 4,000 shares of "SAFKOSPINN" on 13-06-2021 in 4 howlas in the public market.

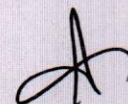

From the above table, it is observed that Md. Sajib Hossain and his associates jointly hold more than 10% of the total paid up shares of SAFKOSPINN.

Findings-3:

It appears that Md. Sajib Hossain (BO ID # 1204290062837591) and his associates have violated the following:

- আমি মোঃ সুলায়মান আমি নিজ নামে তিনটি বিও হিসাব খুলি যার বিও আইডি- যথাক্রমে- ১২০১৮২০০৫৭৭১৩৭১৬, ১২০২২২০০৬১৬৬৯৫১৮ এবং ১২০৩৬৩০০৬১৬৫৫০৯২। আপনাদের চিঠিতে উল্লেখিত জনাব মোঃ সজিব হোসেন, যার বিও আইডি-১২০৪২৯০০৬২৮৩৭৫৯১. তার সাথে আমার ৪০০০ শেয়ারের ক্রস ট্রেডিং দেখানো হয়েছে এ বিষয়ে আমার বক্তব্য হলো: আমি মার্কেট প্রাইস অনুসারে নিটিং এর উদ্দেশ্যে শেয়ার বাই-সেল করেছি। ক্রস ট্রেডিং এর যে অভিযোগ আনা হয়েছে তা সম্পূর্ণ ভিত্তিহীন।
- ২০১৯ সালে আমি এভারেজ ২০.৫০ টাকা বাজারমূল্যে SAFKOSPINN শেয়ারটি বাই করি। আমি শেয়ারটি বাই করার পর থেকে শেয়ারটির প্রাইস ক্রমাগত কমে কমে করোনার পর ০৯ টাকায় চলে আসে। আমি ৫০% এর অধিক আনারিয়েলাইজড লসের সম্মুখীন হয়েছি, COVID-19 পরের সময়ে SAFKOSPINN ফ্লোর প্রাইসে অবস্থান করে। আমি আমার আনারিয়েলাইজড লস কমিয়ে আনার উদ্দেশ্যে SAFKOSPINN শেয়ারটি পুনরায় বিভিন্ন প্রাইসে বাই করে আমার এভারেজ ক্রয়মূল্যে কমিয়ে নিয়ে আসি।

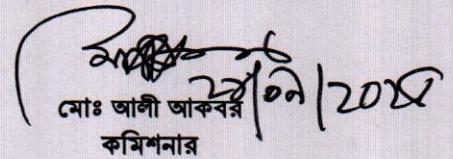
