

Closing price of HIMADRI share as on 27.04.2023 was Tk. 38.80 and closing price of the same was Tk. 2790.20 as on 28.08.2023. During this period from 27.04.2023 to 28.08.2023, price of HIMADRI shares was increased by Tk. 2751.40 which is approximately 7091% higher compared to closing price of 27.04.2023.

A. Trade details of M/S Ovi Bricks and associates:

M/S Ovi Bricks was the top buyer of "HIMADRI" share for the period from 27.04.2023 to 28.08.2023. After examining the relevant documents, it was found that the said client is associated with another three accounts from which they traded shares of "HIMADRI" during the investigation period. Details are as follows:






Green triangle represents trade of HIMADRI by M/S Ovi Bricks and his associates







As per DSE trade data, it was observed that M/S Ovi Bricks and associates bought 181,243 shares and sold 68,679 shares of "HIMADRI" from public market during the period from 27.04.2023 to 17.09.2023. With the said BO accounts, M/S Ovi Bricks and associates traded 116.56% shares of "HIMADRI" during the investigation period and realized a capital gain of Tk. 20,288,423.22 from the trading of "HIMADRI" share during the investigation period. They also had unrealized gain of TK 799,530,084.18 during the period.

Findings- 1:

As per section 17 of the Securities and Exchange Ordinance, 1969, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of including its purchase by others or depressing its price for the purpose of inducing its sale by others;"

It is evident that M/S Ovi Bricks and associates was involved directly and indirectly in a series of transactions of HIMADRI share with his aforesaid BO accounts in order to create the appearance of active trading and raising of price of the said share.

Contravention(s)-1:

It appears that M/S Ovi Bricks (BO ID # 1206280075277461) and associates has violated the followings:

• Section 17(e)(v) of the Securities and Exchange Ordinance, 1969 by directly and indirectly effecting a series of transactions of "HIMADRI" shares creating the appearance of active trading therein and raising price of the said share.

B. Observations- 2:

After analyzing the trade pattern of the clients, the investigation team found that M/S A R Traders (Client Code 25001 of Innova Securities Limited) bought 19,592 shares of "HIMADRI" from another account named Md. Rafiqul Bari (client code 3043 of UCB Stock

Brokerage Limited) on 07/05/2023 and 02/07/2023 by 9 howlas in the public market which involved no change in beneficial ownership.

Besides, Md. Rafiqul Bari (client code 3043 of UCB Stock Brokerage Limited) bought 31,927 shares of "HIMADRI" from his another account named M/S A R Traders (Client Code 25001 of Innova Securities Limited) on 18/06/2023 by 1 howla and 20/06/2023 by 1 howla in the block market which involved no change in beneficial ownership.

It is mentionable here that Mr. Md. Rafiqul Bari is the proprietor of M/S A R Traders as found from the Customer account information form submitted by the TREC Holder.

Details of the above mentioned two accounts and the trade are as follows:

Contravention(s)-2:

It appears that M/S A R Traders (BO ID# 1206280075639086) and Md. Rafiqul Bari (BO ID# 1205590066854027) have violated the following:

• Section 17(e)(iii) of Securities and Exchange Ordinance, 1969, by effecting the transactions of 51,519 shares of "HIMADRI" on different dates in 11 howlas in the public and block market which involved no change in beneficial ownership.

Observation- 3:

M/S Ovi Bricks was the top buyer of "HIMADRI" share for the period from 27.04.2023 to 28.08.2023. After examining the relevant documents, it was found that the said client is associated with four accounts from which he and his associates traded shares of HIMADRI during the investigation period.

As per the Customer Account Information Form and B/O account opening forms, it was observed that the address of the client codes# 15034, 25001 and 15031 of Innova Securities Limited and client code# 3043 of UCB Stock Brokerage Limited are the same as HOUSE-911, ROAD-13, AVENUE-2, MIRPUR DOHS, DHAKA-1216. Besides, Md. Rafiqul Bari (client code# 3043) maintained account with UCB Stock Brokerage Limited as well as he is the proprietor and contact person of the account named M/S A R Traders (client codes# 25001 of Innova Securities Limited).

As per the instrument ledger and portfolio statement of M/S Ovi Bricks, Mr. Md. Rafiqul Bari and their associates collected from Innova Securities Limited and UCB Stock Brokerage Limited, it was observed that they had collectively acquired more than 10% shares of "HIMADRI" during the investigation period. Details are given below:

This downtrend continued throughout 2022. The bearish trend also continues in 2023, average daily market turnover has dropped sharply reflecting the actual bearish sentiment Despite of the negative impact on the market, we are working to support the

We have the positive intention to support the market, we assure you that we have the full support for the capital market during the crisis period. Please accept the following explanation regarding your observations of the trading of Himadri Limited:

01. Trading of shares of HIMADI Limited by M/S AR Traders and Md, Rafigul Bari:

We would like to inform you that I, Md, Rafigul Bari (BOID: 1205590066854027). Managing Director of Innova Securities Limited and the proprietor of M/S AR Traders (BOID: 1206280075639086). I have been working in the capital market from 2021 by getting a license as a stockbroker from the BSEC While commencing my journey in the capital market, I have been investing in the listed securities by analyzing the future cash flow and business forecasting of the company. In case of the Himadri Limited, it is seen that the company is a unique listed company with DSE by nature of the business, and seems that future cash flow and business might increase in considering the global food crisis. I bought the shares of Himadri Limited through the two accounts mentioned above as a long-term investment policy. In the case of investment in Himadri Limited, my strategy is to hold the shares for a long time Currently, I am holding most of the shares in my account that I bought during the period which showed the unrealized gain in my portfolio. Please be informed that I have to show a profit in my sole tradership company (M/S AR Traders) in terms of submission of income tax returns and to get the tax rebate, for that reason, I have to transact some shares within my accounts as there were no options to transfer the shares through off- market in the capital market.

I assure you that there was no intention to breach section 17 (e) (iii) of the Securities and Exchange Ordinance, 1969 but to consider the tax advantage by transacting some shares within the aforementioned two accounts and I made this mistake due to lack of knowledge of the securities law. To the best of my knowledge, I did not violate section 17 (e) (iii) of the Securities and Exchange Ordinance, 1969.

02. Acquiring shares of Himadri Limited:

This is to inform here that after commencing the operations of Stock broker activities, we have a business plan to open customers loan accounts with a single present address in considering the expansion of the brokerage business through margin accounts. In this regard, we opened accounts such as M/S Ovi Bricks and Munir Traders with a single address for the management of the margin account in terms of getting the cash dividends warrants in the same address. The mentioned clients invested in the different securities and Himadri Limited at their discretion without a margin loan There is no relationship among the Md Rafiqul Bari, M/S Ovi Bricks and Munir Traders. As there is no relationship with M/S Ovi Bricks and Munir Traders of Md. Considering the aforementioned circumstances, please exempt us from the claim mentioned in your letter and forgive us unconditionally."
