A. Top Traders:

The price of shares of "DHAKAINS" was increased from Tk. 41.80 to 86.70 which was increased by 107.42% for the period from 04.04.2021 to 03.05.2021. The list of major buyers of the period is as follows:

Findings:

➤ It was observed that Kazi Sadia Hasan (Client code # 3898 of UCB Stock Brokerage Limited) was the top buyer of shares of "DHAKAINS" from 04.04.2021 to 03.05.2021. The said client also maintained another code # S2131 of SBL Capital Management Limited. and was the 4th top buyer position during the investigation period. It was also observed that the aforesaid client was associated with Md. Abul Khayer (client code # 7647 of UCB Stock Brokerage Limited and code # ABM645 of Agrani Equity & Investment Limited) who was the 5th and 6th top buyer of shares of "DHAKAINS" from 04.04.2021 to 03.05.2021. It may be mentioned that Md. Abul Khayer is the husband of Kazi Sadia Hasan. The aforesaid clients collectively traded 28.05% of the said shares during the investigation period.

c) Trade monitoring screenshots of Kazi Sadia Hasan and Md. Abul Khayer (Public market):

The Investigation Team collected Trade monitoring screenshots from the Surveillance Department on some trading dates where appearance of active trading of Kazi Sadia Hasan and Md. Abul Khayer was observed to influence the price of 'DHAKAINS'.

After scrutinizing the Trade monitoring screenshots collected from Surveillance Department, it is found that Kazi Sadia Hasan and Md. Abul Khayer was involved in trading of shares of 'DHAKAINS' which influenced price of shares of the said company on several dates as follows:

❖ It was observed that on 21/04/2021, total number of trade of shares of 'DHAKAINS' in the market was 681, whereas number of trades executed by Kazi Sadia Hasan and Md. Abul Khayer were 335 which is approximately 49.20% of the total number of trades in the market. Again, total volume of 'DHAKAINS' in the market on that day was 11,20,907 whereas buy volume by the said client was 724,354 which is approximately 64.62% of the total volume in the market. It is evident that the client had significant participation in the market on 21/04/2021 in trading of 'DHAKAINS' share.

On 21-04-2021, trading of DHAKAINS share was started at Tk. 51.70 which is similar as the YCP of Tk. 51.70. On that day, Kazi Sadia Hasan and Abul Khayer started series of trading at 10:14:33 at price Tk. 51.90 and induced the same to rise to Tk. 56.80 up to 11:00:03. It can also be observed from the above graph that Kazi Sadia Hasan and Abul Khayer executed significant trades during this time period. It is mentionable here that from 10:14:33 to 11:00:03, Kazi Sadia Hasan and Abul Khayer bought 724,354 shares of DHAKAINS compared to the total traded share of 1,016,044.

It is also found that during the aforementioned period, Kazi Sadia Hasan and Abul Khayer executed 335 howlas to purchase of shares of DHAKAINS compared to the total number of howlas of 606.

It is observed from the above graphs and screenshot that Kazi Sadia Hasan and Abul Khayer bought 71.29% of the total trades of DHAKAINS shares by executing 335 of total 606 howlas from 10:14:33 to 11:00:03 on 21-04-2021. From 10:14:33 to 11:00:03, Kazi Sadia Hasan and Abul Khayer induced the price to rise from Tk. 51.90 to Tk. 56.80. Thus it seems that Kazi Sadia Hasan and Abul Khayer were actively trying to lift the price of DHAKAINS share. At the end of the day price of DHAKAINS share was increased by Tk. 5.10 which is approximately 9.86% higher than YCP.

❖ It was observed that on 28/04/2021, total number of trades of DHAKAINS in the market was 1338, whereas number of trades executed by Kazi Sadia Hasan and Md. Abul Khayer were 212 which is approximately 15.80% of the total number of trades in the market. Again, total volume of DHAKAINS in the market on that day was 13,33,045 whereas buy volume by the said client was 5,00,000 which is approximately 37.5% of the total volume in the market. It is evident that

the client had significant participation in the market on 28/04/2021 in trading of share of 'DHAKAINS'.

On 28-04-2021, trading of DHAKAINS share was started at Tk. 73.00 which is Tk. 1.40 more than the YCP of Tk. 71.60. On that day, Kazi Sadia Hasan and Abul Khayer started series of trading at 11:12:35 at price of Tk. 69.20 and induced the same to rise to Tk. 75.00 up to 11:16:06. It can also be observed from the above graph that Kazi Sadia Hasan and Abul Khayer executed significant trades during this time period. It is mentionable here that from 11:12:35 to 11:16:06, Kazi Sadia Hasan and Abul Khayer bought 500,000 shares of DHAKAINS compared to the total traded share of 521,192.

It is also found that during the aforementioned period, Kazi Sadia Hasan and Abul Khayer executed 212 howlas to purchase of shares of DHAKAINS compared to the total number of howlas of 234.

It is observed from the above graphs and screenshot that Kazi Sadia Hasan and Abul Khayer bought 95.93% of the total trades of DHAKAINS shares by executing 212 of total 234 howlas from 11:12:35 to 11:16:06 on 28-04-2021. From 11:12:35 to 11:16:06, Kazi Sadia Hasan and Abul Khayer induced the price to rise from Tk. 69.20 to Tk. 75.00. Thus it seems that Kazi Sadia Hasan and Abul Khayer were actively trying to lift the price of DHAKAINS share.

d) Gain/Loss of Kazi Sadia Hasan and Md. Abul Khayer by trading shares of DHAKAINS from 04.04.2021 to 03.05.2021:

As per DSE trade data, Kazi Sadia Hasan and Md. Abul Khayer bought total 3,424,354 shares of "DHAKAINS" from 04.04.2021 to 03.05.2021. They traded 28.05% of total trade volume of 22,343,721 shares of "DHAKAINS" with the said BO accounts and realized a capital gain of Tk. 43,461,404.89 by trading of shares of "DHAKAINS" during the investigation period. Moreover, their unrealized capital gain is Tk. 9,551,704.61 during the investigation period.

Findings:

As per Section 17(e)(v) of the Securities and Exchange Ordinance, 1969, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of inducing its purchase by others or depressing its price for the purpose of inducing its sale by others;"

Hence, it is observed from the aforesaid discussion that Kazi Sadia Hasan and Md. Abul Khayer was involved directly and indirectly in a series of transaction of share of "DHAKAINS" in order to create the appearance of active trading of the said share.

Contraventions: Through the aforesaid activities it appears that Kazi Sadia Hasan and Md. Abul Khayer (BOID # 1205150068192662) has violated Section 17(e)(v) of Securities and Exchange Ordinance, 1969 by directly or indirectly effecting a series of transactions in the shares of "DHAKAINS" creating the appearance of active trading therein and raising price of the said share.

"With due respect, we, Md. Abul Khayer and Kazi Sadia Hasan hereby would like to take the opportunity to explain our position in respect of your letter no. # BSEC/Enforcement/3254/2022/305 dated February 15, 2022 regarding DHAKAINS.

Pursuant to your above-mentioned letter, we have tried to trade significant quantity of shares to improve the market scenario and increase the market volume in the very difficult situation like COVID-19 hit the capital market significantly where market volume reduced to very low and capital market was depressed and volume was required to stabilize the market. We, all know that the current economic data shows significant growth trajectory of Bangladesh Economy under the daughter of Bangabandhu HH Prime Minister Sheikh Hasina M.P., the depressed situation of capital market will not sustain, it must be rebounded significantly. It needs leader with good number of market participants who will work for the development of market like existing Chairman sir along with his team of BSEC.

In addition to the above, we have given buy order to our concerned trader to buy the mentioned shares of NRBC Bank Limited on the different dates but not for manipulative purpose. This is fresh buy and sales of shares. We believe that the price of NRBC is undervalued that's why we given this

buy order to purchase shares. We have no other motive but to get the opportunity to get the gain from undervalued shares which is evident from its current price.

We always try to comply rules and regulation at the time trade. In addition to this, our trade volume helps to provide sufficient liquidity in the market which ultimately increase the turnover of the exchanges."
