যেহেতু, ঢাকা স্টক এক্সচেঞ্জ লিমিটেড-এর তদন্ত কমিটি surveillance Note-022/2022 তারিখ মার্চ ২৭, ২০২২ এবং Regulation 16(3)(C)(ii) and (d)(v) of Dhaka Stock Exchange (Board and Administration) Regulations, 2013 এ প্রদত্ত ক্ষমতা বলে Alltex Industries Limited (ALLTEX) এর শেয়ার লেনদেনের ২৭.১২.২০২১ থেকে ২২.০৩.২০২২ পর্যন্ত সময়ের জন্য তদন্ত (investigation) কার্যক্রম পরিচালনা করেছে এবং কমিশনে এ সংক্রান্ত একটি প্রতিবেদন দাখিল করেছে। তদন্ত প্রতিবেদন থেকে অন্যান্যের মধ্যে নিম্নলিখিত বিষয়গুলি উপস্থাপিত হয়:

Trends of closing Price and trade volume of "ALLTEX" in public Market.

YCP of ALLTEX as on 27.12.2021 was Tk. 14.90 and closing price of the same was Tk. 28.10 as on 22.03.2022. During this period the investigation team found that the price of ALLTEX share was increased by Tk. 13.20 which is approximately 88.59% higher compared to YCP of 26.12.2021.

A. Mr. Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates:

Observation-1:

After examining account opening form and relevant documents, it is revealed that Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates maintained 28 (twenty-eight) accounts with SBL Capital Management Limited, Eminent Securities Ltd. and United Financial Trading Company Limited in trading of share of ALLTEX during the investigation period. Details of these accounts are given below:

As per DSE trade data, **Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates** bought 51,17,844 shares and sold 71,11,683 shares of ALLTEX from both block and public market during the period from **27.12.2021 to 22.03.2022**. With 28 (twenty-eight) BO accounts **Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates** collectively traded 27.55% of total trade volume and realized a capital gain of BDT 2,07,35,697.28 from the trading of "ALLTEX" share during the investigation period.

Findings:

As per **Section 17(e)(v) of the Securities and Exchange Ordinance, 1969**, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

.....

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of inducing its purchase by others or depressing its price for the purpose of inducing its sale by others;"

It seems to us that **Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates** executed series of transactions through the aforesaid BO accounts creating the appearance of active trading therein and also influencing the price of ALLTEX.

Contraventions:

It appears that **Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates** violated the following:

- **Section 17(e)(v) of Securities and Exchange Ordinance, 1969** by directly or indirectly executing series of transactions in the shares of ALLTEX creating the appearance of active trading therein.

Observation-2:

It is also observed that during the investigation period **Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates** executed trade of ALLTEX share within themselves which created a false and misleading appearance of active trading of this security. As a result, 21,13,967 shares of ALLTEX were executed in 230 howla(s) where the related account holders acted as both buyer and seller as shown below:

Findings:

As per section 17 of the Securities and Exchange Ordinance, 1969 (XVII of 1969), "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(ii) create a false and misleading appearance of active trading in any security;

Whereas, it has been found that during the investigation period Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their mentioned associates exchanged 21,13,967 shares of ALLTEX with one another. Therefore, such trading of ALLTEX shares created a false and misleading appearance of active trading of this security.

Contravention(s):

It appears that Md. Masudur Rahman Sheikh, Md. Jashim Uddin and their associates violated the following:

- Section 17(e)(ii) of the Securities and Exchange Ordinance, 1969 for executing trade of ALLTEX share by creating false and misleading appearance of active trading in that security.

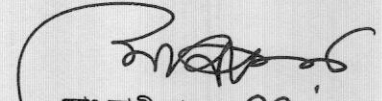
