



Trends of closing price and trade volume OF "FINEFOODS" in public market



Yesterday Closing Price (YCP) of the share of FINEFOODS as on 28-10-2024 was Tk. 155.80 and closing price of the same was Tk. 218.60 as on 24-12-2024. During this period from 28-10-2024 to 24-12-2024, price of the share of FINEFOODS was increased by Tk. 62.80 which is approximately 40.31% higher compared to closing price of 27-10-2024.

Observations and findings:

A. TRADE DETAILS OF THE CITY BANK LTD. AND ASSOCIATES:

Observation- 1:

After analyzing documents, it is observed that The City Bank Ltd. (Client code # C082 of City Brokerage Limited) was the top buyer of FINEFOODS share from 28-10-2024 to 24-12-2024. It was observed that the aforesaid client was involved with the following accounts through which they traded shares of "FINEFOODS" during the investigation period.

As per letter reference CBL/HO/HR/2024/19 dated June 10, 2024 submitted by City Brokerage Limited that Md. Sanowar Khan is the "Portfolio manager, Capital Market" of The City Bank Limited since June 10, 2024.







It was observed in the above graph that on 26-11-2024, total number of trades of FINEFOODS in the market was 2109, whereas number of trades (buy) executed by THE CITY BANK LTD. and associate(s) were 95 which is approximately 4.50% of the total number of trades in the market. Again, total traded volume of FINEFOODS in the market on that day was 394,605 whereas buy volume by the said client(s) was 17,000 which is approximately 4.31% of the total traded volume in the market.






It is observed from the above graphs and screenshot that THE CITY BANK LTD. and associate(s) bought 88.39% of the total trades of FINEFOODS shares by executing 47 of total 52 howlas from 11:34:08 to 11:35:28 on 26-11-2024. From 11:34:08 to 11:35:28, THE CITY BANK LTD. and associate(s) induced the price to rise from Tk. 208.20 to Tk. 209.80 (induced the price by Tk. 1.60). Thus it seems that THE CITY BANK LTD. and associate(s) were actively trying to lift the price of FINEFOODS share.


It was observed in the above graph that on 27-11-2024, total number of trades of FINEFOODS in the market was 1064, whereas number of trades (buy) executed by THE CITY BANK LTD. and associate(s) were 95 which is approximately 8.93% of the total number of trades in the market. Again, total traded volume of FINEFOODS in the market on that day was 234,603 whereas buy volume by the said client(s) was 60,834 which is approximately 25.93% of the total traded volume in the market.




It is observed from the above graphs and screenshot that THE CITY BANK LTD. and associate(s) bought 92.60% of the total trades of FINEFOODS shares by executing 73 of total 97 howlas from 14:13:15 to 14:17:37 on 27-11-2024. From 14:13:15 to 14:17:37, THE CITY BANK LTD. and associate(s) induced the price to rise from Tk. 207.90 to Tk. 209.90 (induced the price by Tk. 2.00). Thus it seems that THE CITY BANK LTD. and associate(s) were actively trying to lift the price of FINEFOODS share.



It is observed from the above graphs and screenshot that THE CITY BANK LTD. and associate(s) bought 58.86% of the total trades of FINEFOODS shares by executing 12 of total 20 howlas from 11:14:59 to 11:15:42 on 03-12-2024. - 2) NAV per share: TK 11 only, new asset revaluation is expected in 2025*
- 3) EPS: 2023 was .07, 2024 was 88 & 2025 expected is around TK 6 which is 700% growth over 2024.*


