From the above discussion, the Monitoring Team observed that the Company partially rectified the aforesaid non-compliance.

Company-related Findings:

- 1. The Company preserved list of its Board of Directors, Shareholders, Authorized Representatives and Employees.
- 2. It was revealed to the Inspection Team that the company conducted only 02 (two) meetings of Board of Directors during the year of 2021.

Whereas as per section 96 of The Companies Act 1994, "Meeting of Board: -In the case of every company a meeting of its Board of Directors shall be held at least once in every three months and at least four such meetings shall be held in every year."

It appeared that the company violated:

- Section 96 of the Companies Act 1994;
- by not holding required number of Board Meetings during the respective periods.

Updated Status:

The company has held 03 (three) meetings of Board of Directors in the year 2022 whereas as per section 96 of the Companies Act 1994, the company should have held at least 04 (four) meetings in a calendar year. It is also mentionable that the company held all three meetings between August to December 2022, having no meeting held in the first 7 months.

3. It was also revealed to the Inspection Team that the company did not conduct Annual General Meeting (AGM) during the year of 2021.

by not holding Annual General Meeting (AGM) during the respective year.

Updated Status:

The company held an Annual General Meeting (AGM) on 22 February 2022, where two directors and the chairman of the company were present. The company has enclosed the minutes of the AGM.

AML & CFT-related Findings:

1. After analyzing the relevant documents, it was observed that the company did not submit Suspicious Transaction Report (STR) to the BFIU on regular basis.

They have sent an E-mail to Monitoring and Compliance Department of DSE to inform about their server down at 12:31 a.m. on that inspection day while the inspection team was presented in that company. However, the inspection team collected backup files of the BackOffice Software of the previous day (Wednesday, 22 December 2021).

Later, the inspection team sent an E-mail to Sinha Securities Limited on 06 January 2022 to send 02 (two) officers of the concerned vendor of their BackOffice Software to install the necessary software to extract data from the collected backup files. In this regard, their effective measures were not noticed and they failed to manage the concerned officials of their vendor to come at DSE.

It is mentioned here that April/20 & May/20 were also closed the share market. Due to the above reasons, we have incurred a heavy loss.

On the other hand, the expenditure was gradually increased but income of the house was almost nil. The clarifications are as follows:

In this context, we have already closed all your required joint and individual BO accounts (Sheet enclosed). We will alert in future for BO open either single and joint
