যেহেতু, কমিশন, Globe Securities Limited (ডিএসই টিআরইসি নং-১৮৯) কে তার আবেদনক্রমে, নির্ধারিত শর্তাবলীতে সিকিউরিটিজ ক্রয় বিক্রয় কর্মকাণ্ড পরিচালনা করার জন্য 'বাংলাদেশ সিকিউরিটিজ অ্যান্ড এক্সচেঞ্জ কমিশন' (অতঃপর 'কমিশন' বলে উল্লিখিত) 'বাংলাদেশ সিকিউরিটিজ অ্যান্ড এক্সচেঞ্জ কমিশন' আইন, ১৯৯৩ (১৯৯৩ সনের ১৫ নং আইন) এর ১০(১) এ প্রদত্ত কর্মকাণ্ড বলে সিকিউরিটিজ ও এক্সচেঞ্জ কমিশন (স্টক-ডিলার, স্টক-ব্রোকার ও অনুমোদিত প্রতিনিধি) বিধিমালা, ২০০০ এর বিধি ৫(৫) সহ পঠিত স্টকব্রোকার/ডিলার রেজিস্ট্রেশন সার্টিফিকেট প্রদান করেছে;

A. The inspecting officers examined all documents related to the Customers Consolidated Bank Account of Globe Securities Limited. The details of the findings are delineated below:

It reflects from the above table that the said broker did not have available fund for payment to the clients. They had a fund deficit of Tk. **19, 46, 93,414.00** as on June 30, 2012, Tk. **17, 62, 76,039.00** as on June 30, 2011 and Tk. **10, 62, 77,997.00** as on June 30, 2010 respectively against clients deposit of Tk. 19, 78, 82,818.00 as on June 30, 2012, Tk. 17, 88, 91,507.00 as on June 30, 2011 and Tk. 11, 62, 06,422.00 as on June 30, 2010. The said broker used the deposits of the clients for the company's own purpose, which is contrary to the Securities related laws.

Contravention: Through the aforesaid activities Globe Securities Limited violated the Rules (8A) of the Securities and Exchange Rules, 1987 and সিকিউরিটিজ ও এক্সচেঞ্জ কমিশন (স্টক-ডিলার, স্টক ব্রোকার ও অনুমোদিত প্রতিনিধি, বিধিমালা, ২০০০ এর বিধি ১২ by not maintaining the Consolidated Customer Account for the purpose of dealing money only for the deposit of the money received from and for, any payment of money to and for customers.

B. After randomly checking relevant documents collected from Globe Securities Ltd., It was found that in respect of the following clients bought non-margin securities (as the PE ratio is over 40) using margin loan as shown below:-

As per Section 8 (1)(cc)(i) of Securities and Exchange Rules, 1987, "all receipts and payments in respect of all transactions, or series of transactions, for one customer in excess of taka five lac shall be carried out other than by cash".

Contravention: Through the aforesaid activities Globe Securities Ltd. violated the rules 8(c) (i) of the Securities and Exchange Rules, 1987 by receiving amount more than Tk 05 (five) lac from its clients.
