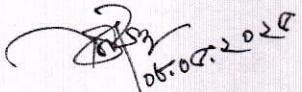

যেহেতু, Securities and Exchange Ordinance, 1969 এর Section 2 (cc) মোতাবেক “কমিশন” অর্থ বাংলাদেশ সিকিউরিটিজ অ্যান্ড এক্সচেঞ্জ কমিশন যা বাংলাদেশ সিকিউরিটিজ অ্যান্ড এক্সচেঞ্জ কমিশন আইন, ১৯৯৩-এর অধীনে গঠিত;

যেহেতু, ঢাকা স্টক এক্সচেঞ্জ লিমিটেড- এর সার্ভাইল্যান্স নোট- 70/2023 dated September 13, 2023 এবং Dhaka Stock Exchange (Board and Administration) Regulations, 2013 -এ প্রদত্ত ক্ষমতাবলে ঢাকা স্টক এক্সচেঞ্জ লিমিটেড- এর তদন্ত দল ১৬-০৭-২০২৩ থেকে ১২-০৯-২০২৩ পর্যন্ত সময়ের জন্য Crystal Insurance Company Limited (CRYSTALINS) এর শেয়ার লেনদেনের তদন্ত (investigation) কার্যক্রম পরিচালনা করেছে এবং কমিশনে এ সংক্রান্ত একটি প্রতিবেদন দাখিল করেছে। তদন্ত প্রতিবেদন থেকে অন্যান্যের মধ্যে নিম্নলিখিত বিষয়গুলি উপস্থাপিত হয়:

YCP of the shares of CRYSTALINS as on 16.07.2023 was Tk. 41.20 and the closing price of the same was Tk. 85.40 as on 12.09.2023. During this period from 16.07.2023 to 12.09.2023, the price of the shares of ‘CRYSTALINS’ was increased by Tk. 44.20, which is approximately 107.28% higher compared to the Closing Price of 13.07.2023

YCP of the shares of CRYSTALINS as on 16.07.2023 was Tk. 41.20 and the closing price of the same was Tk. 85.40 as on 12.09.2023. During this period from 16.07.2023 to 12.09.2023, the price of the shares of ‘CRYSTALINS’ was increased by Tk. 44.20 which is approximately 107.28% higher compared to the Closing Price of 13.07.2023

➤ Eshaal Communication Limited (client code # 2194 of NRBC Bank Securities Limited) was one of the top buyers of the shares of “CRYSTALINS” from 16.07.2023 to 12.09.2023. After examining the relevant documents, it was found that the said client is associated with the following accounts from which they traded shares of “CRYSTALINS” during the investigation period. Details are as follows:

On 16-07-2023, the total number of trades of CRYSTALINS in the market was 583, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 87 which is approximately 14.92% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 564,902 whereas the buy volume by the said client(s) was 200,000 which is approximately 35.40% of the total traded volume in the market.

On 20-07-2023, the total number of trades of CRYSTALINS in the market was 947, whereas number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 155 which is approximately 16.37% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 2,123,927 whereas the buy volume by the said client(s) was 350,000 which is approximately 16.48% of the total traded volume in the market.

On 25-07-2023, the total number of trades of CRYSTALINS in the market was 2211, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 492 which is approximately 22.25% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 2,961,951 whereas the buy volume by the said client(s) was 1,376,714 which is approximately 46.48% of the total traded volume in the market.

On 27-08-2023, the total number of trades of CRYSTALINS in the market was 1313, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 638 which is approximately 48.59% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 1,159,289 whereas the buy volume by the said client(s) was 814,442 which is approximately 70.25% of the total traded volume in the market.

On 28-08-2023, the total number of trades of CRYSTALINS in the market was 1289, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 307 which is approximately 23.82% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 807,274 whereas the buy volume by the said client(s) was 179,873 which is approximately 22.28% of the total traded volume in the market.

On 30-08-2023, the total number of trades of CRYSTALINS in the market was 1015, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 157 which is approximately 15.47% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 652,824 whereas the buy volume by the said client(s) was 195,955 which is approximately 30.02% of the total traded volume in the market.

On 10-09-2023, the total number of trades of CRYSTALINS in the market was 2149, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 640 which is approximately 29.78% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 1,682,811 whereas the buy volume by the said client(s) was 609,808 which is approximately 36.24% of the total traded volume in the market.

On 11-09-2023, the total number of trades of CRYSTALINS in the market was 1674, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 586 which is approximately 35.01% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 2,368,025 whereas the buy volume by the said client(s) was 939,471 which is approximately 39.67% of the total traded volume in the market.

On 12-09-2023, total number of trades of CRYSTALINS in the market was 2065, whereas the number of trades (buy) executed by Eshaal Communication Limited, Md. Abul Khayer and associates were 772, which is approximately 37.38% of the total number of trades in the market. Again, the total traded volume of CRYSTALINS in the market on that day was 1,261,995, whereas buy volume by the said client(s) was 660,260, which is approximately 52.32% of the total traded volume in the market.

As per DSE trade data, it was observed that **Eshaal Communication Limited, Md. Abul Khayer and associates** bought 11,602,705 shares and sold 6,185,978 shares of "CRYSTALINS" from the public and block market during the period from 16.07.2023 to 12.09.2023. With the said BO accounts, Eshaal Communication Limited, Md. Abul Khayer and associates traded 28.86% shares of "CRYSTALINS" during the investigation period and realized a capital gain of Tk. 23,662,488.21 from the trading of "CRYSTALINS" shares during the investigation period. They also had an unrealized gain of TK 70,577,528.39 during the period.

As per Section 17 of the Securities and Exchange Ordinance, 1969, "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(v) directly or indirectly effect a series of transactions in any security creating an appearance of active trading therein or of raising of price for the purpose of including its purchase by others or depressing its price for the purpose of inducing its sale by others;"

It is evident that Eshaal Communication Limited, Md. Abul Khayer and associates were involved directly and indirectly in a series of transactions of shares of 'CRYSTALINS' with their aforesaid BO accounts to create an appearance of active trading and raising of price of the said share.

Contravention(s):

It is evident that Eshaal Communication Limited (BOID # 1205950075311207), Md. Abul Khayer (BOID # 1201950062164535) and associates have violated the following:

□ *Section 17(e)(v) of the Securities and Exchange Ordinance, 1969 by directly and indirectly effecting a series of transactions of shares of "CRYSTALINS" creating an appearance of active trading therein and raising the price of the said share.*

➤ As per DSE trade data, it was found that **Konika Afroze (Client Code 7677 of UCB Stock Brokerage Limited)** bought 13,735 shares of CRYSTALINS from her other account named Konika Afroze (client code 2748 of Standard Bank Securities Limited) on 25/07/2023 by 13 howlas in the public market which involved **no change in beneficial ownership**.

As per section 17(e)(iii) of the Bangladesh Securities and Exchange Ordinance, 1969 (XVII of 1969), "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(iii) effect any transaction in such security which involves no change in its beneficial ownership;"

Contravention (s):

Through the aforesaid activities, it is evident that **Konika Afroze (BO ID# 1205590072553290 and 1205600072553290)** has violated:

□ *Section 17(e)(iii) of the Securities and Exchange Ordinance, 1969, by effecting the transactions of 13,735 shares of CRYSTALINS on 25/07/2023 by 13 howlas, which involved no change in beneficial ownership.*

➤ After analyzing the trade pattern of the clients, the investigation team found that ESHAAL COMMUNICATION LTD. (BOID 1205950075311207), MONARCH MART LTD (BOID 1205950075322573), MD. ABUL KHAYER (BOID 1205590071091116), KONIKA AFROZE (BOID 1205600072553290), ABUL KALAM MATBER (BOID 1605180073785828), AL AMIN CHEMICAL INDUSTRIES LT (BOID 1205590075398978), MD. HUMAYAN KABIR (BOID 1205590067630195), Shakib Al Hasan (BOID 1205590074169484), MD. ABUL KHAYER (BOID 1205950071091116) and Kazi Sadia Hasan (BOID 1604530066385504) were involved in trading in

shares of "CRYSTALINS" within the investigation period and these accounts are acting as counterparties of each other for 601,176 shares of "CRYSTALINS" on different dates in 29 howlas in the public and block market.

As per section 17 of the Securities and Exchange Ordinance, 1969 (XVII of 1969), "No person shall, for the purpose of inducing, dissuading, effecting, preventing or in any manner influencing or turning to his advantage, the sale or purchase of any security, directly or indirectly, -

(e) do any act or practice or engage in a course of business, or omit to do any act which operates or would operate as a fraud, deceit or manipulation upon any person, in particular-

(ii) create a false and misleading appearance of active trading in any securities;"

It is found that associates of Mr. Md. Abul Khayer and ESHAAL COMMUNICATION LTD. acted as counterparty of each other for 601,176 shares of "CRYSTALINS" on different dates in 29 howlas in the public and block market.

Contravention(s):

It is apparent that ESHAAL COMMUNICATION LTD. (BOID 1205950075311207), MONARCH MART LTD (BOID 1205950075322573), MD. ABUL KHAYER (BOID 1205590071091116), KONIKA AFROZE (BOID 1205600072553290), ABUL KALAM MATBER (BOID 1605180073785828), AL AMIN CHEMICAL INDUSTRIES LT (BOID 1205590075398978), MD. HUMAYAN KABIR (BOID 1205590067630195), Shakib Al Hasan (BOID 1205590074169484), MD. ABUL KHAYER (BOID 1205950071091116) and Kazi Sadia Hasan (BOID 1604530066385504) have violated the following:

❑ *Section 17(e)(ii) of the Securities and Exchange Ordinance, 1969, by executing trades that created a false and misleading appearance of active trading in securities.*

➤ As per the ledger, instrument ledger, and portfolio statement of Eshaal Communication Limited, Md. Abul Khayer and associates collected from different TREC Holders, and it was observed that they had **collectively acquired more than 10% shares of "CRYSTALINS"** during the investigation period. Details are given below:

I will be more cautious in next time so that this will never happen inshaAllah. The trade volume is only 13,735 out of my total holdings of around 12,00,000 lac shares. So, it is clearly indicated that it is purely unintentional mistakes.

Contravention 2: I invested in the mentioned company based on company's fundamental strength that is evident in its' business like, premium collection, eps, growth of the company, NAV, dividend etc. I have no intention to create any false or misleading appearance of trade. I invested in this particular share in the long- term basis that I hold till now. It is clearly evident that I have no intention for any misleading trade of shares in this particular case. The price was in upward position on several

occasion but I didn't sale it fully still I hold in this price level of 60 taka only. Even all my profit evaporated due to this steep market fall in last few months but I am holding it considering its long-term prospect.

Contravention 3: I have my individual tax files and can trade based on my own decision thus I am not violated the section 4(1) of Bangladesh Securities and Exchange Commission (Substantial Acquisition of Shares and Takeovers) Rules, 2018. I am holding only around 3% of total shares of above-mentioned share as mentioned in your letter.
