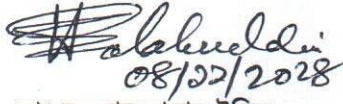

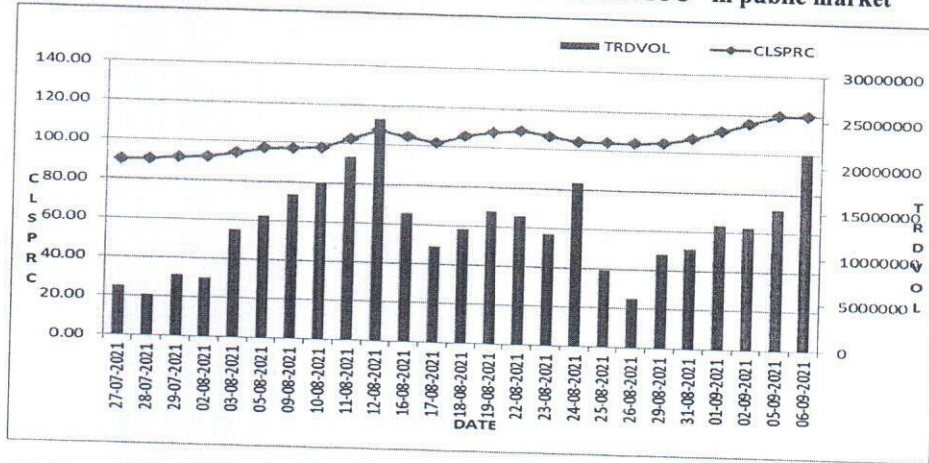

Trends of closing price and trade volume OF "BEXIMCO" in public market



YCP of BEXIMCO as on 28-07-2021 was Tk. 90.00 and closing price of the same was Tk. 119.80 as on 06-09-2021. During this period the investigation team found that the price of BEXIMCO share was increased by Tk. 29.80 which is approximately 33.11% higher compared to Close Price of 27-07-2021.

Mr. Mosfequr Rahman, Mr. Momtazur Rahman & their Associates:

Observation-1:

Momtazur Rahman (client code # J3463 & BOID # 1605400019678719 of Janata Capital and Investment Limited (traded through ICB Securities Trading Company Limited)) was the 6th buyer of shares of "BEXIMCO" from the period of 28.07.2021 to 06.09.2021. His brother, Mosfequr Rahman (client code # J3461 & BOID # 1605400019678794 of Janata Capital and Investment Limited (traded through ICB Securities Trading Company Limited)) was the 7th top buyer of shares of "BEXIMCO" for the said period. After examining the relevant documents, it was also observed that the said clients participated in trading of shares of "BEXIMCO" in association with total 12 (Twelve) accounts and the details of the same are delineated as follows:

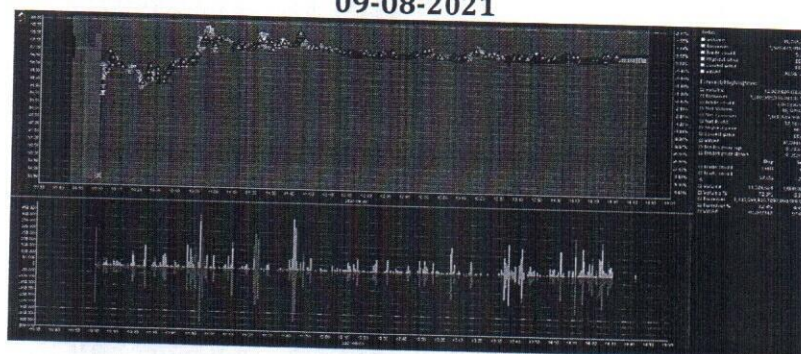

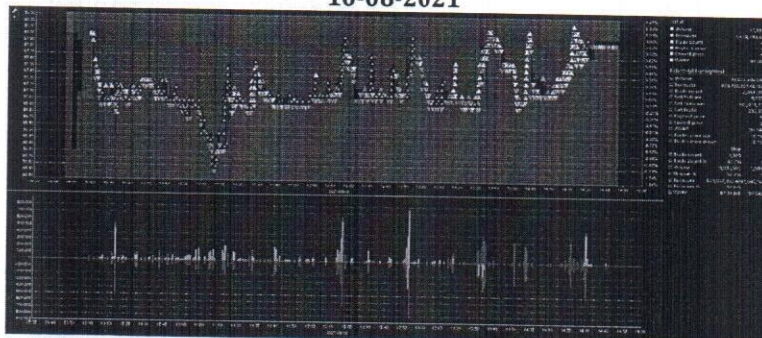

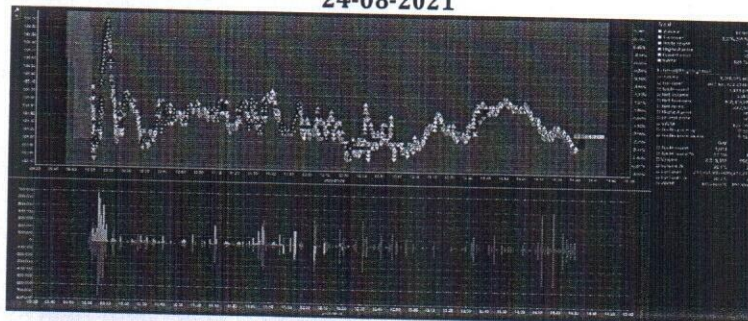

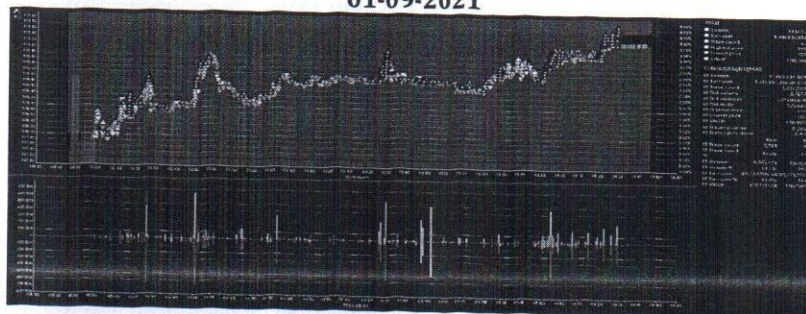

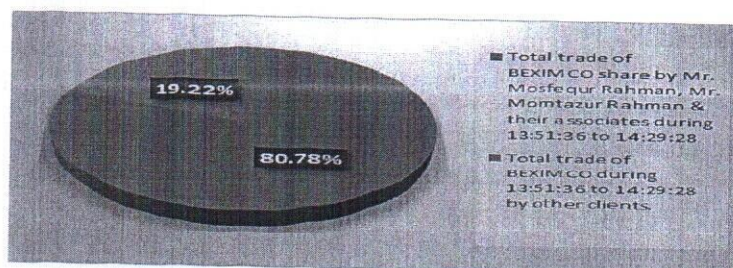

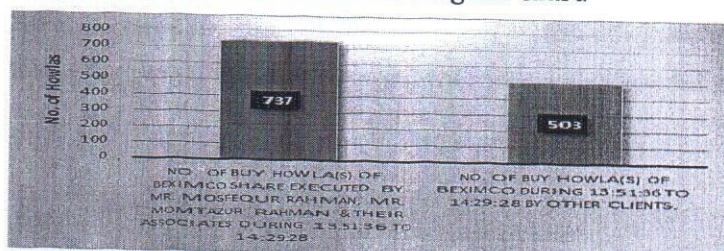

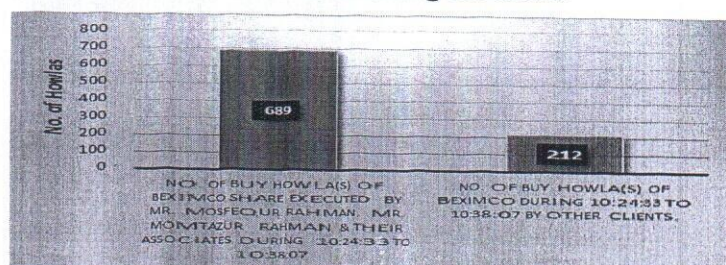

As per DSE trade data, Mr. Mosfequr Rahman, Mr. Momtazur Rahman & their associates bought 74,398,389 shares and sold 38,772,424 shares of "BEXIMCO" from both block and public market during the period from 28.07.2021 to 06.09.2021 with their 12 (twelve) BO accounts. With the said 12 (twelve) accounts Mr. Mosfequr Rahman, Mr. Momtazur Rahman & their associates collectively traded 35.69% of total trade volume and realized a capital gain of Tk. 1,095,931,953.89 from the trading of "BEXIMCO" share during the investigation period. It is also mentionable that this group of clients had significant amount of unrealized gain of Tk. 6,360,504,391.75.

(v) directly or indirectly effect a series of transactions in any security creating the appearance of active trading therein or of raising of price for the purpose of inducing its purchase by others or depressing its price for the purpose of inducing its sale by others;"

Hence, it is observed from the aforesaid discussion that Mr. Mosfequr Rahman, Mr. Momtazur Rahman & their associates were involved directly and indirectly in a series of transaction of share of 'BEXIMCO' in order to create the appearance of active trading of the said share.

Contraventions-1:

It appears that **Mr. Mosfequr Rahman** (BOID # 1605400019678794), **Mr. Momtazur Rahman** (BOID # 1605400019678719) & **their associates** have violated the following-

- **Section 17(e)(v) of Securities and Exchange Ordinance, 1969** by directly or indirectly effecting a series of transactions in the shares of 'BEXIMCO' creating the appearance of active trading therein and raising price of the said share.

Since Mr. Mosfequr Rahman and Mr. Momtazur Rahman are brothers and their companies JUPITAR BUSINESS LTD., ART INTERNATIONAL LTD. and APOLLO TRADING LIMITED are involved in trading of shares of "BEXIMCO" among themselves, it created a false and misleading appearance of active trading of this security.

It is observed that the said clients were involved directly and indirectly in transaction of shares of BEXIMCO in order to create a false and misleading appearance of active trading of the said share.

It appears that Mr. Mosfequr Rahman, Mr. Momtazur Rahman, JUPITAR BUSINESS LTD., ART INTERNATIONAL LTD. and APOLLO TRADING LIMITED have violated section 17(e)(ii) of the Securities and exchange ordinance, 1969 for directly and indirectly involvement in transaction of shares of BEXIMCO in order to create a false and misleading appearance of active trading of the said share.

Contravention(s)-3:

It appears that **Mr. Mosfequr Rahman** (BOID # 1605400019678794), **Mr. Momtazur Rahman** (BOID # 1605400019678719) & **their associates** have violated the following:

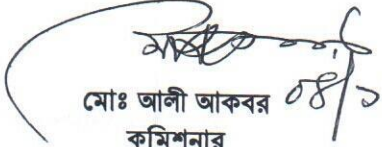
