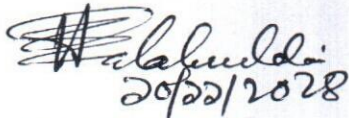

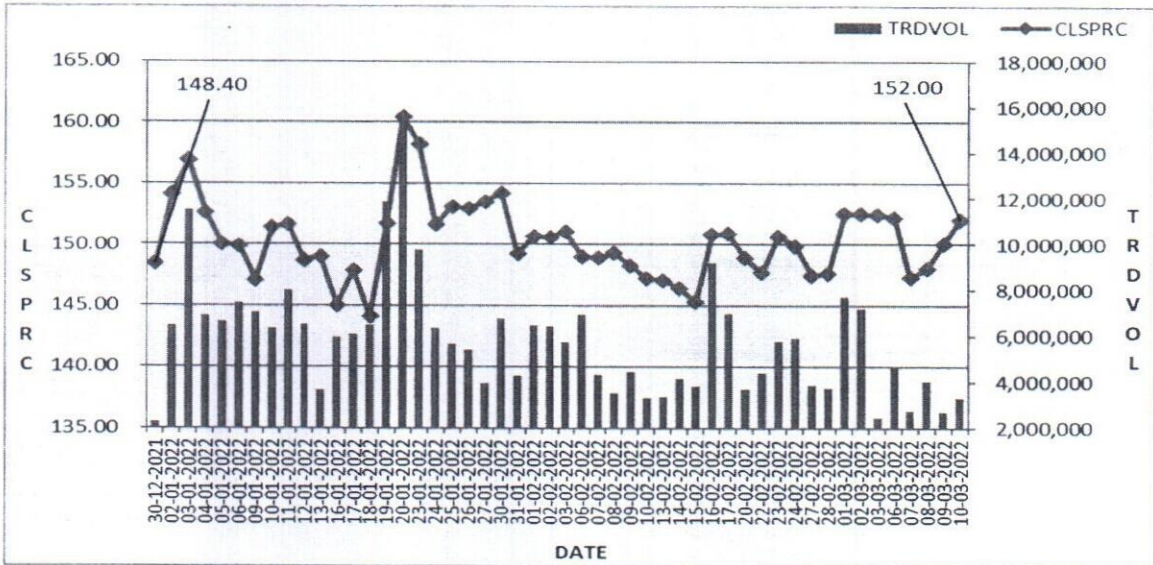

YCP of the shares of BEXIMCO as on 02.01.2022 was Tk. 148.40 and closing price of the same was Tk. 152.00 as on 10.03.2022. During this period from 02.01.2022 to 10.03.2022, price of the shares of 'BEXIMCO' was increased by Tk. 3.60 which is approximately 2.4% higher compared to Closing Price of 30.12.2021.

A. Trading of Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates

Observation(s)-1:

After analyzing documents, it is observed that Jupitar Business Limited represented by **Mr. Mosfequr Rahman**, Client code # J3504 of Janata Capital and Investment Limited (traded through ICB Securities Trading Company Limited) was the 2nd top buyer of the shares of "BEXIMCO" from 02.01.2022 to 10.03.2022. During the investigation period, Mr. Mosfequr Rahman actively participated in trading shares of the aforesaid company with an association with 7 (seven) more accounts set out below:

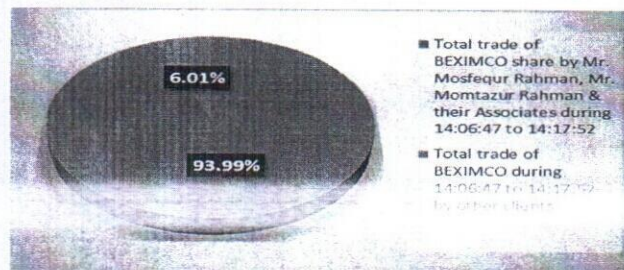

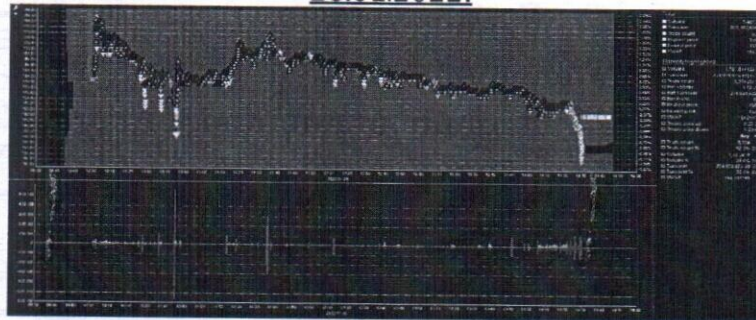

Again, total traded volume of BEXIMCO in the market on that day was 3,849,352 whereas buy volume by the said client(s) was 1,257,250 which is approximately 32.66% of the total traded volume in the market. It is evident that the client had significant participation in the market on 27-02-2022 in trading of BEXIMCO share.

On 27-02-2022, trading of BEXIMCO share was started at Tk. 150.00 which is Tk. 0.10 more than the YCP of Tk. 149.90. On that day, Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates started series of trading at 14:03:39 at price Tk. 147.00 and induced the same to rise to Tk. 148.30 up to 14:07:23. It can also be observed from the above graph that Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates executed significant trades during this time period. It is mentionable here that from 14:03:39 to 14:07:23, Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates bought 277,512 shares of BEXIMCO compared to the total traded share of 287,267. This is shown in the following Pie Chart.



It is also found that during the aforementioned period, Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates executed 145 howlas to purchase of shares of BEXIMCO compared to the total number of howlas of 209 as shown in the following Bar Chart.



It is observed from the above graphs and screenshot that Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates bought 96.60% of the total trades of BEXIMCO shares by executing 145 of total 209 howlas from 14:03:39 to 14:07:23 on 27-02-2022. From 14:03:39 to 14:07:23, Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates induced the price to rise from Tk. 147.00 to Tk. 148.30. Thus it seems that Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates were actively trying to lift the price of BEXIMCO share.

With these BO accounts, Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates traded 24.61% shares of "BEXIMCO" during the investigation period and realized a capital gain of Tk. 1,648,509,460.60 from the trading of shares of "BEXIMCO" during the investigation period. It is also mentionable that they had significant amount of unrealized gain of Tk. 2,774,751,327.55

Findings - 1:

It is evident that **Mr. Mosfequr Rahman, Mr. Momtazur Rahman and their Associates** were involved directly and indirectly in a series of transactions of shares of 'BEXIMCO' with his aforesaid BO account in order to create an appearance of active trading and raising of price of the shares of the aforesaid company.

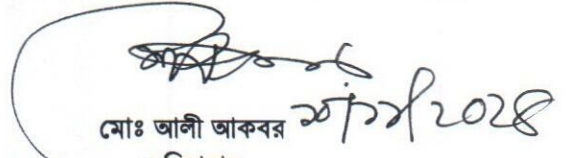
