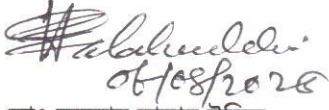

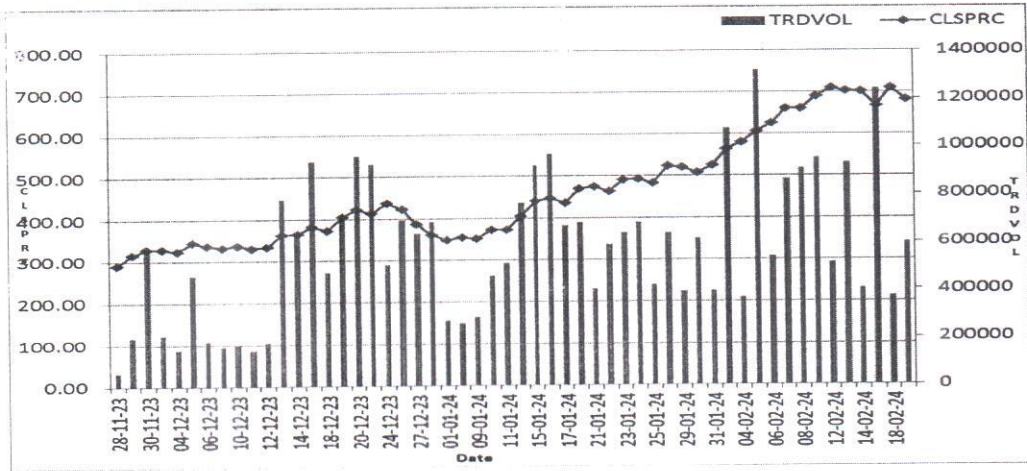

Description of alleged violation of securities laws:

Pursuant to Surveillance Note No. 09/2024 dated February 28, 2024 and in exercise of the power conferred by Regulation 16(3)(c)(ii) and (d)(v) of the Dhaka Stock Exchange (Board and Administration) Regulations, 2013, the investigation team of DSE investigated the share trading of Orion Infusion Ltd. (ORIONINFU) for the period from 29.11.2023 to 19.02.2024 and prepared a report which is submitted to the Commission. The investigation team submitted the investigation report to the Commission. The investigation team randomly examined the documents collected from different TREC holders of clients regarding share trading of Orion Infusion Limited. From the investigation report it appears, among others, that:

Trends of closing price and trade volume OF 'ORIONINFU' in public market



Yesterday Closing Price (YCP) of the share of ORION INFUSION LTD. as on 29-11-2023 was Tk. 290.70 and closing price of the same was Tk. 681.20 as on 19-02-2024. During this period from 29-11-2023 to 19-02-2024, price of the share of ORION INFUSION LTD. was increased by Tk. 390.50 which is approximately 134.33% higher compared to closing price of 28-11-2023.

A. Trading of Shahdat Hossain & Associates:

Observation:

After examining account opening forms and other relevant documents, it is revealed that Shahdat Hossain & Associates maintains several accounts with different depository participants while trading the shares of 'ORIONINFU' for the period from 29.11.2023 to 19.02.2024. The investigation team noticed that the following clients are associated on the basis of **some common attributes** among them. The details of the accounts are delineated as follows:

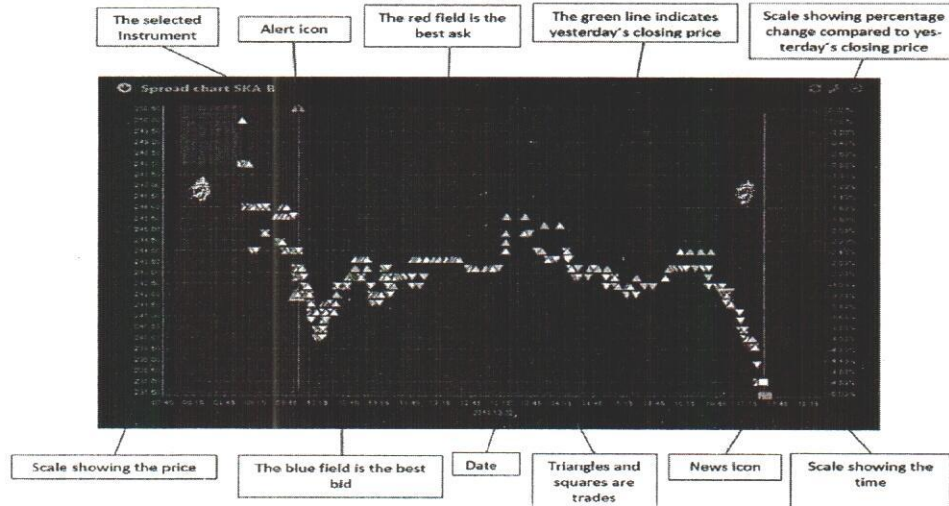

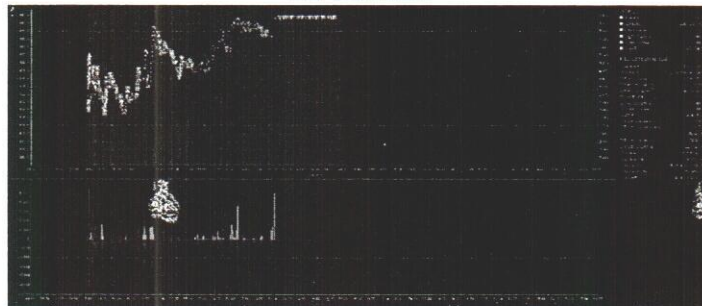
▲ Green triangle represents trade of 'ORIONINFU' by *Shahdat Hossain & Associates*

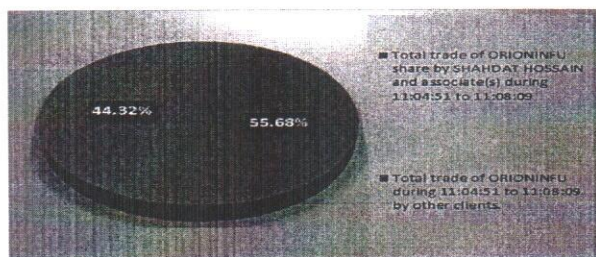

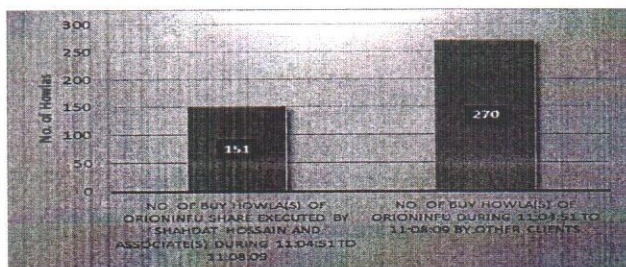

It was observed in the above graph that on 15-01-2024, total number of trades of ORIONINFU in the market was 5758, whereas number of trades (buy) executed by SHAHDAT HOSSAIN and associate(s) were 1309 which is approximately 22.73% of the total number of trades in the market. Again, total traded volume of ORIONINFU in the market on that day was 918,577 whereas buy volume by the said client(s) was 313,628 which is approximately 34.14% of the total traded volume in the market. It is evident that the client had significant participation in the market on 15-01-2024 in trading of ORIONINFU share.

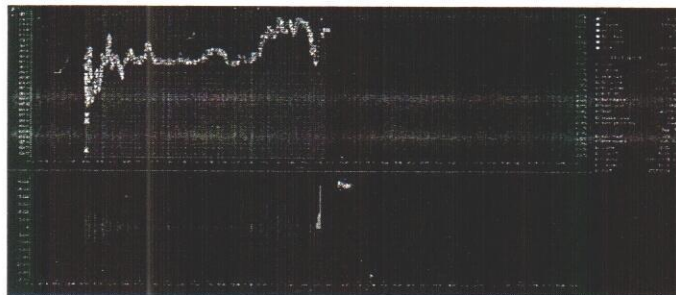

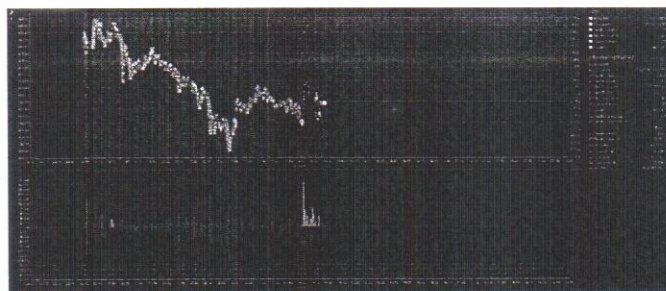

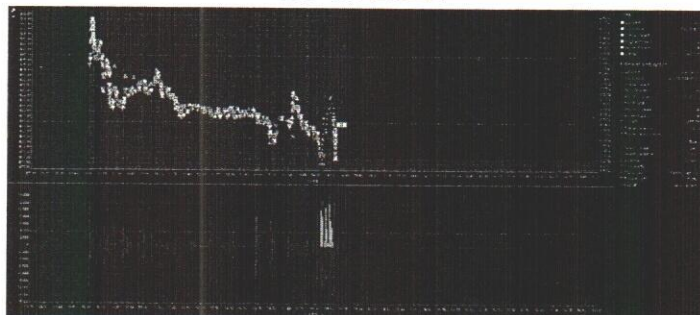

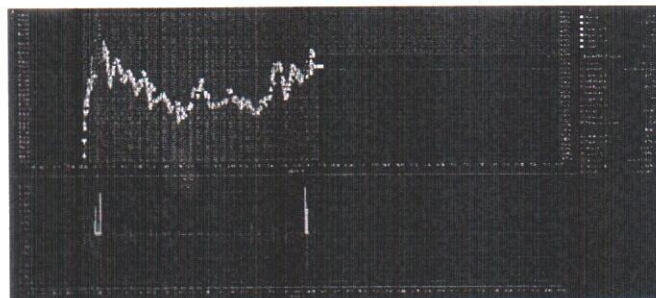

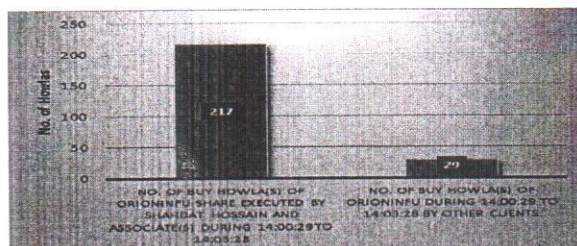

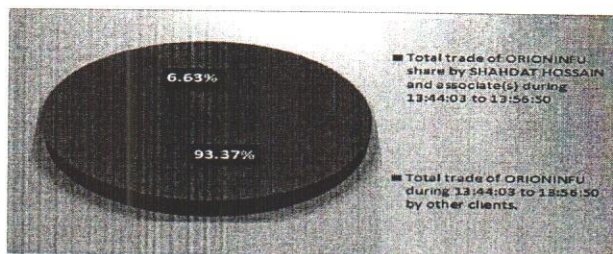

Individual investors like me suffered substantial losses due to declining stock prices and high market volatility. As an investor, I always try to invest according to the rules and regulations related to the capital market. A brief description of my stock market investments is as follows:

Total Investment BDT 16,78,20,000.00, Total Withdrawal BDT 13,38,00,000.00 Total realized Profit/loss BDT 12,72,33,093.53 and unrealized gain (loss) BDT (8,33,37,021.88) My present portfolio position shown that BDT 4,38,96,071.65 profit due to price declining of shares holding in my account.

In view of the alleged breach of law against me, my statement is as follows:

Based on the address information with my BO account some investors are associated with whom I do not know personally and the matching of the information is coincidental. I take my investment decisions very personally and respect the law at all times.

- 1. The trades executed during the period in question were conducted with the sole intent of optimizing investment returns based on market analysis and company fundamentals. There was no deliberate effort to manipulate the price of Orion Infusion shares or create a misleading appearance of trading activity.*
- 2. The observed price movement and trading volume may have been influenced by prevailing market conditions, including market demand, or broader industry trends, rather than any coordinated or manipulative trading activity*
- 3. I would like to emphasize that the trades were conducted independently and not as part of a coordinated effort to artificially influence the market. Any appearance of concentration in trading activity was coincidental and not intended to breach securities regulations.*
- 4. I have always operated in good faith and adhered to the rules and regulations of the Bangladesh Securities and Exchange Commission. To further ensure compliance, I am committed to strengthening my knowledge about securities related laws.*
- 5. I request the honorable Commission to consider this explanation and the absence of any malicious intent. If there were any unintentional lapses in compliance, I assure the Commission that corrective measures will be taken to prevent recurrence*

I remain committed to upholding the integrity of the capital market and cooperating fully with the Commission in this matter"

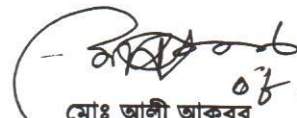
