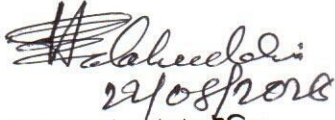

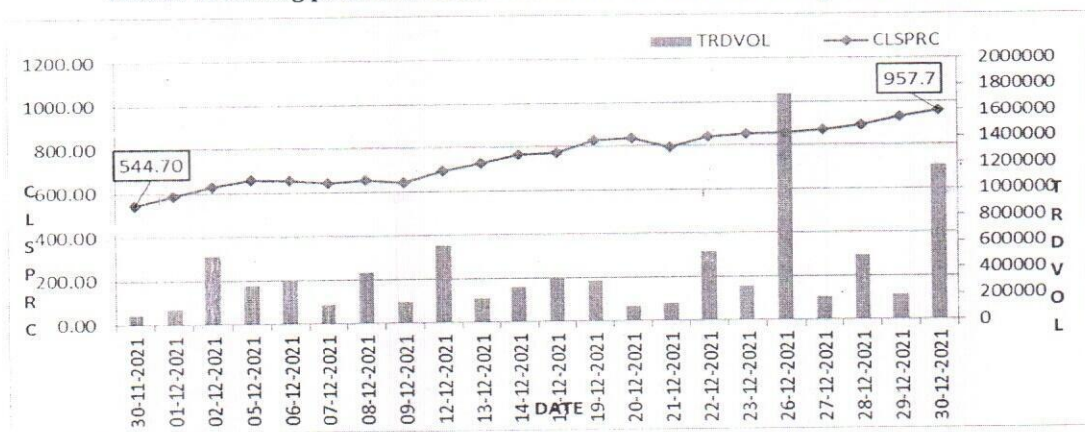

- His father and **5th & 10th** top buyer named **Mr. Abul Kalam Matber** (client code # ABM663 of Agrani Equity & Investment Limited, 9166 of UCB Stock Brokerage Limited, 43878 of EBL Securities Limited and 08003 of IIDFC Securities Limited),
 - His wife and **11th & 12th** top buyer named **Ms. Kazi Sadia Hasan** (Client code # 3998 of UCB Stock Brokerage Limited, S2131 of SBL Capital Management Ltd, 43685 of EBL Securities Ltd),
 - The Softavion Ltd. (client code # 43816 of EBL Securities Limited), the **16th** top buyer,
 - His brother, named **Sajed Madbar** (client code # 10057 of UCB Stock Brokerage Limited) and Mohammad Basher (Client code # 10058 of UCB Stock Brokerage Limited),
 - His sister, named **Konika Afroze** (client code # S2194 of SBL Capital Management Limited),
 - His Brother-In-Law, named **Kazi Farid Hasan** (Client code # 9177 of UCB Stock Brokerage Limited, S11331 of Southeast Bank Capital Services Ltd., 08013 of IIDFC Securities Limited),
 - Mr. Javeed A Matin (client code # S11295 of Southeast Bank Capital Services Ltd.), the director of Monarch Holdings Limited.
 - The D I T Co-Operative Ltd. (client code # 7022 of UCB Stock Brokerage Limited, 1688 of NRBC Bank Securities Limited, S2116 of SBL Capital Management Limited),
 - The Monarch Hotel & Resorts Ltd. (client code # N019 of UCB Investment Limited), Monarch Holdings Limited (Client code # ABM646 of Agrani Equity & Investment Limited) in trading shares of "SONALIPAPR" during the investigation period.

In addition to the above mentioned accounts, it is also observed that **Mr. Abul Khayer** has also participated in trading the shares of aforementioned company along with 04 (four) more accounts maintained in his name (Client code # 1689 of NRBC Bank Securities Limited, the top 15th top buyer, client code # 7647 of UCB Stock Brokerage Limited, ABM645 of Agrani Equity & Investment Limited and V01550 of Vertex Stock and Securities Limited).

However, with these **30 (Thirty)** accounts, they jointly traded **44.56%** shares of "SONALIPAPR" during the investigation period.

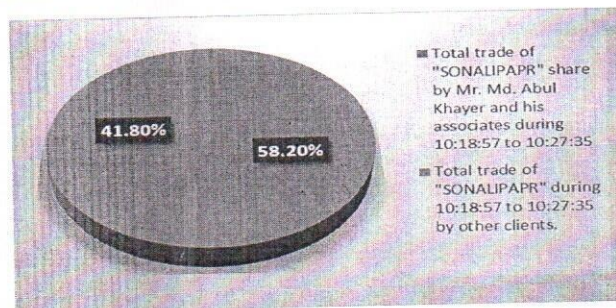

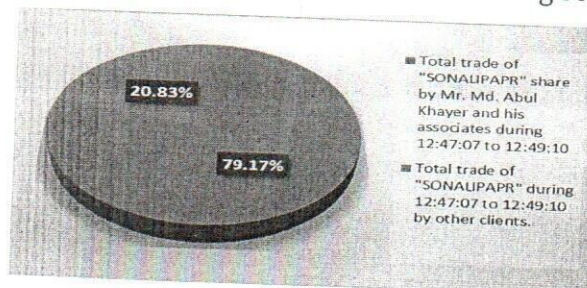

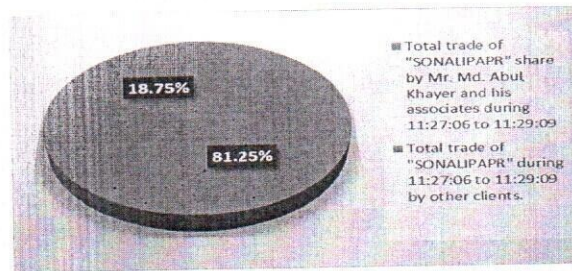

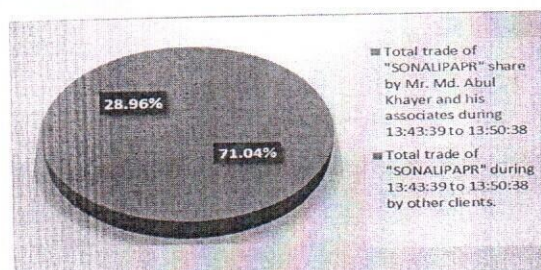

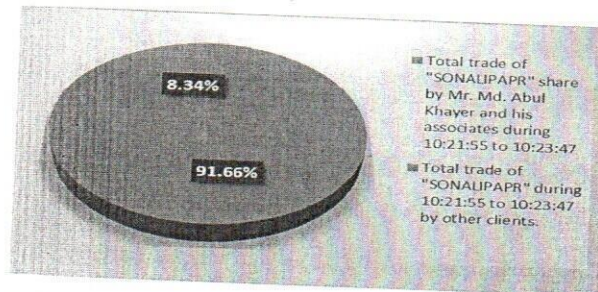

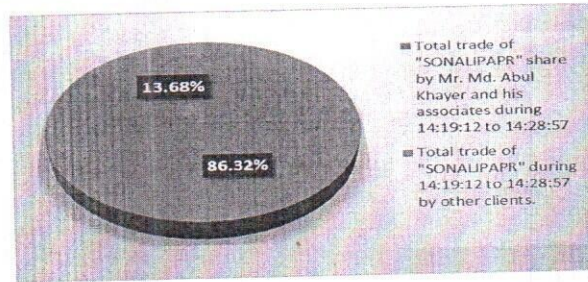

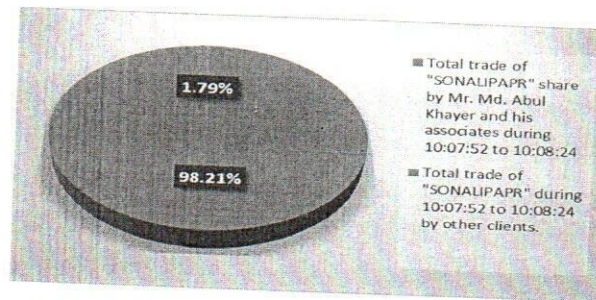

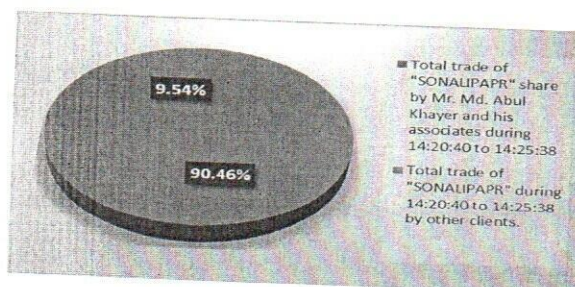

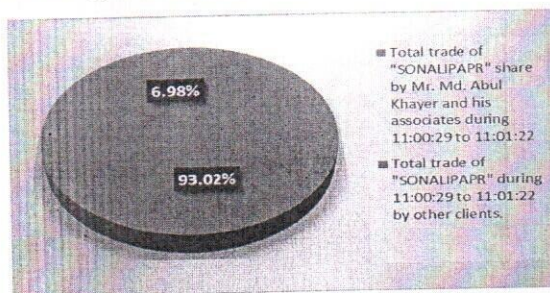

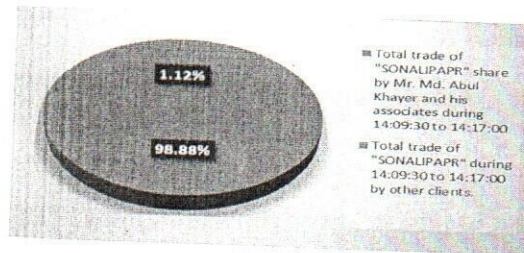

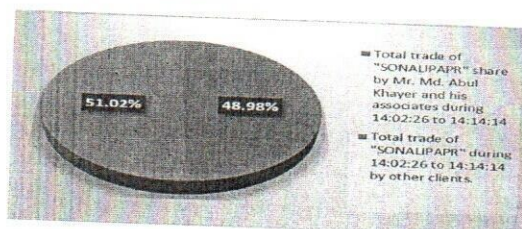
