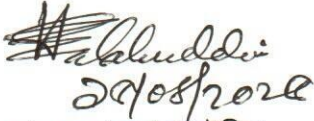

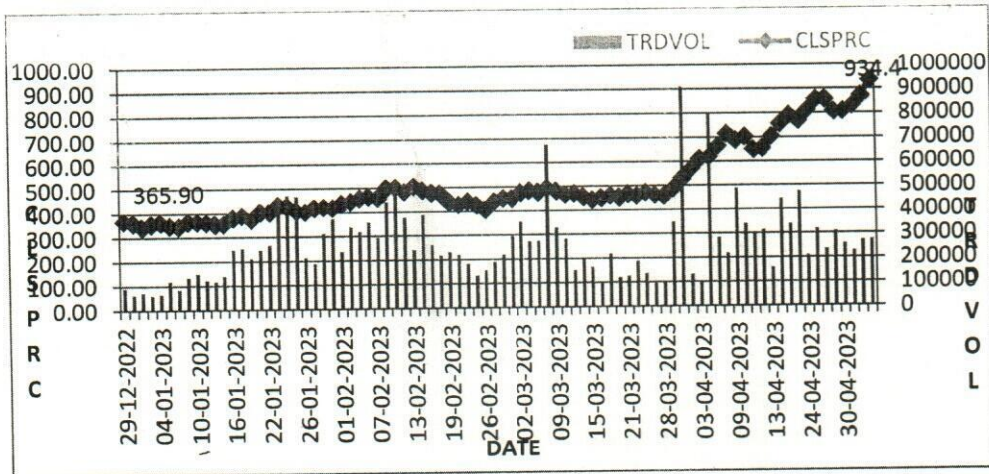

Description of alleged violation of securities laws:

Whereas, Pursuant to the letter No. BSEC/Surveillance/2003-0103 (Vol:II)/249 dated May 09, 2023 received from the Bangladesh Securities and Exchange Commission (BSEC), the investigation team of Dhaka Stock Exchange Ltd. (DSE) investigated the share trading of Gemini Sea Food Ltd. (GEMINISEA) for the period from 01.01.2023 to 07.05.2023 and prepared this report. The investigation team randomly examined the documents collected from different TREC holders of clients regarding share trading of Gemini Sea Food Limited. From the investigation report it appears, among others, that:

OBSERVATION ON THE PRICE MOVEMENT OF GEMINI SEA FOOD LTD.:



YCP of GEMINISEA share as on 01.01.2023 was Tk. 365.90 and closing price of the same was Tk. 934.40 as on 07.05.2023. During this period from 01.01.2023 to 07.05.2023, price of GEMINISEA shares was increased by Tk. 568.50 which is approximately 158.71% higher compared to closing price of 29.12.2022.

Observations and findings:

The investigation team collected required documents from different TREC holders regarding share trading of Gemini Sea Food Ltd. After examining the relevant documents, our findings are as follows:

- After analyzing documents, it is observed that Ms. Risana Karim (Client code # 11788 of UCB Stock Brokerage Limited) and her brother Mr. Ulfat Karim (Client code # H0840 of NCCB Securities and Financial Services Ltd.) was the top and 2nd top buyer of "GEMINISEA" share from 01.01.2023 to 07.05.2023. Through the aforesaid code Ms. Risana Karim bought 652,872 and sold 453,479 shares which is 4.74% of total traded share of "GEMINISEA" and Mr. Ulfat Karim bought 587,174 and sold 337,090 shares which is 3.96% of total traded share of "GEMINISEA" during the investigation period. It was observed that the aforesaid clients were involved with the following accounts through which they traded shares of "GEMINISEA" during the investigation period.

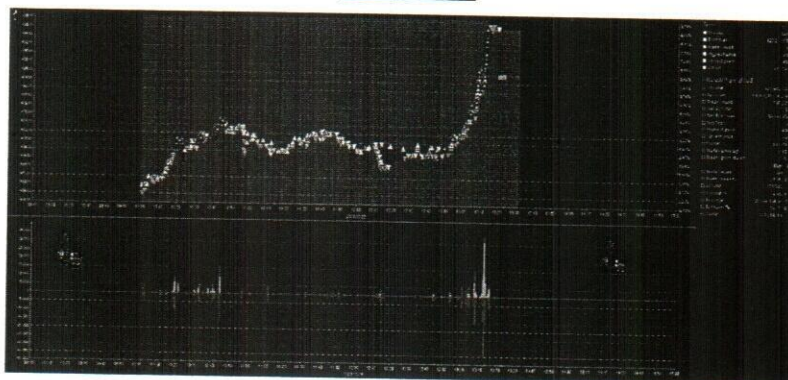

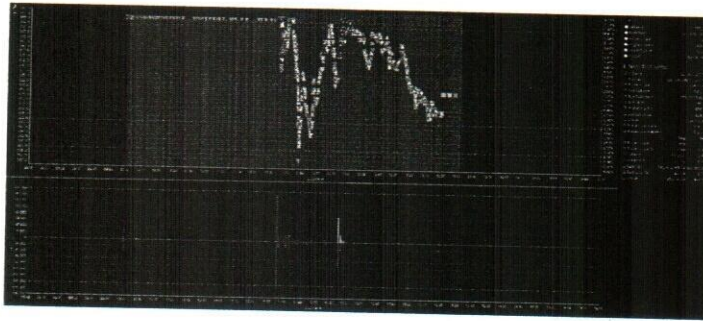

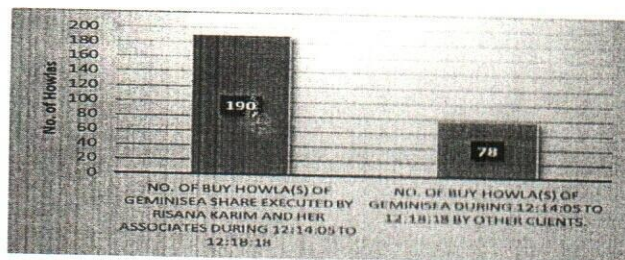

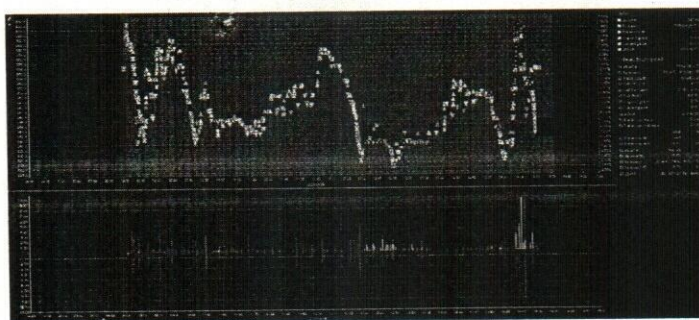

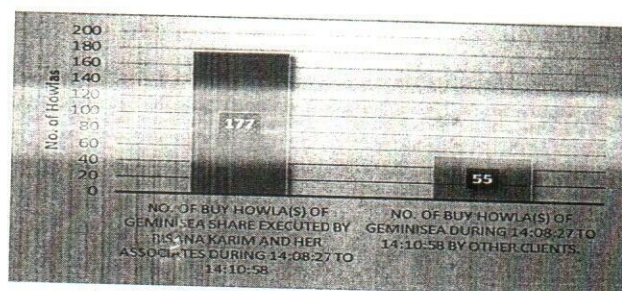

It is evident that Risana Karim and her associates were involved directly and indirectly in a series of transactions of GEMINISEA share with his aforesaid BO accounts in order to create the appearance of active trading and raising of price of the said share.

Contravention(s)-1:

Risana Karim and her associates have violated the followings:

- Section 17(e)(v) of the Securities and Exchange Ordinance, 1969 by directly and indirectly effecting a series of transactions of "GEMINISEA" shares creating the appearance of active trading therein and raising price of the said share.
