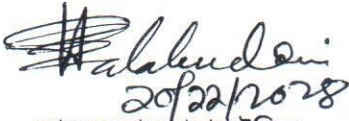

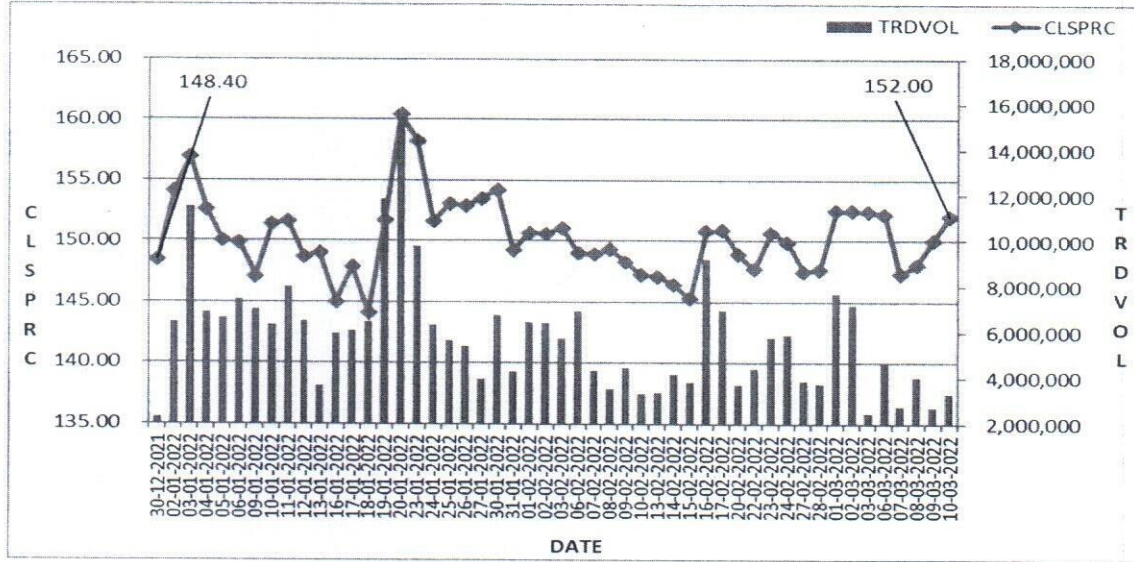

YCP of the shares of BEXIMCO as on 02.01.2022 was Tk. 148.40 and closing price of the same was Tk. 152.00 as on 10.03.2022. During this period from 02.01.2022 to 10.03.2022, price of the shares of ‘BEXIMCO’ was increased by Tk. 3.60 which is approximately 2.4% higher compared to Closing Price of 30.12.2021.

A. Trading of MARJANA RAHMAN & TRADENEXT INTERNATIONAL LIMITED

Tradenext International Ltd. (client code # J3531 & BOID # 1605400072217023 of Janata Capital and Investment Limited (traded through ICB Securities Trading Company Limited) was the top most buyer of shares of “BEXIMCO” from the period of 02.01.2022 to 10.03.2022. After examining the relevant documents, it was also observed Marjana Rahman is the Director of Tradenext International Ltd. and operator of the BOID of the said company. 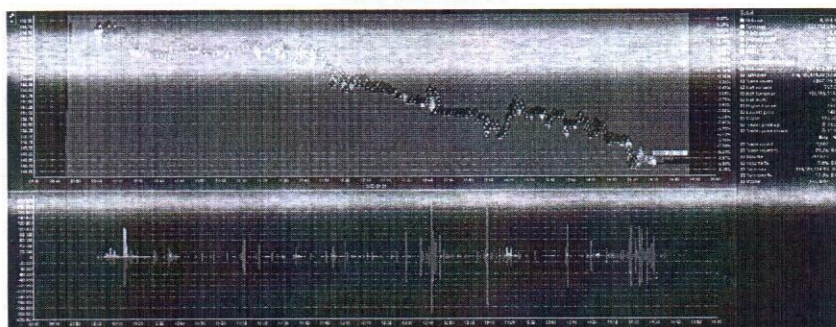

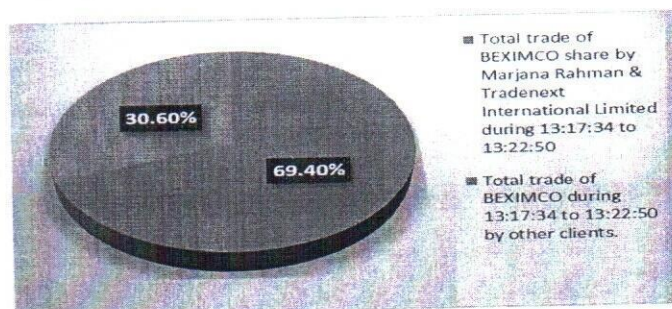

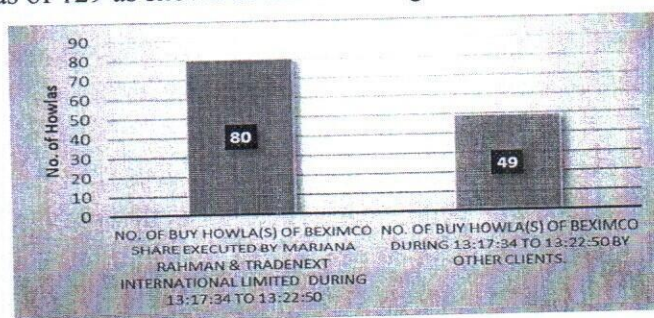

It was observed in the above graph that on 31-01-2022, total number of trades of BEXIMCO in the market was 6170, whereas number of trades (buy) executed by Marjana Rahman & Tradenext International Limited were 1807 which is approximately 29.29% of the total number of trades in the market. Again, total traded volume of BEXIMCO in the market on that day was 4,303,387 whereas buy volume by the said client(s) was 757,873 which is approximately 17.61% of the total traded volume in the market.

On 31-01-2022, trading of BEXIMCO share was started at Tk. 154.50 which is Tk. 0.30 more than the YCP of Tk. 154.20. On that day, Marjana Rahman & Tradenext International Limited started series of trading at 13:17:34 at price Tk. 150.00 and induced the same to rise to Tk. 151.50 up to 13:22:50. It can also be observed from the above graph that Marjana Rahman & Tradenext International Limited executed significant trades during this time period. 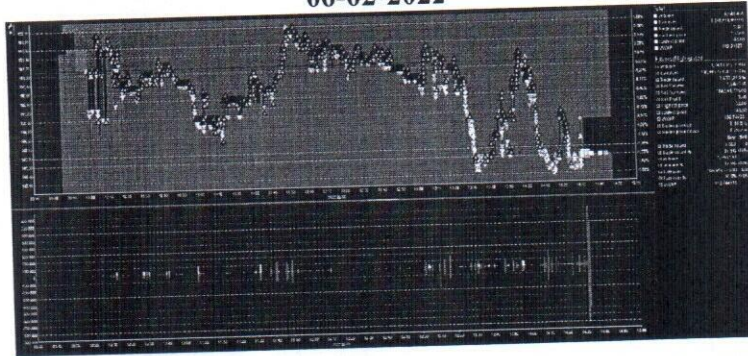

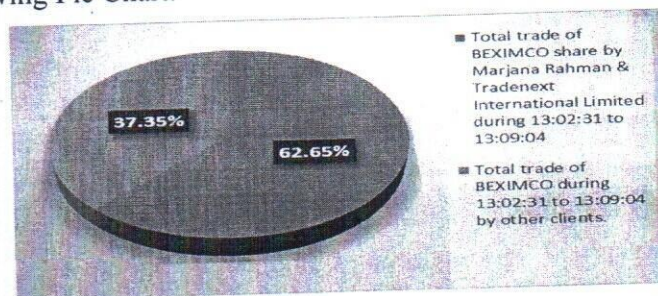

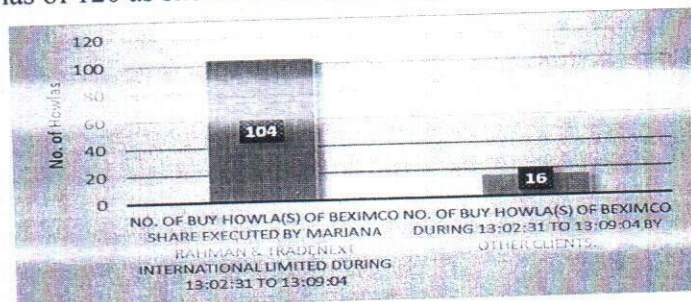


It was observed in the above graph that on 06-02-2022, total number of trades of BEXIMCO in the market was 5022, whereas number of trades (buy) executed by Marjana Rahman & Tradenext International Limited were 1883 which is approximately 37.50% of the total number of trades in the market. Again, total traded volume of BEXIMCO in the market on that day was 6,941,438 whereas buy volume by the said client(s) was 1,240,138 which is approximately 17.87% of the total traded volume in the market.

On 06-02-2022, trading of BEXIMCO share was started at Tk. 151.10 which is Tk. 0.00 which is similar as the the YCP of Tk. 151.10. On that day, Marjana Rahman & Tradenext International Limited started series of trading at 13:02:31 at price Tk. 150.70 and induced the same to rise to Tk. 151.40 up to 13:09:04. 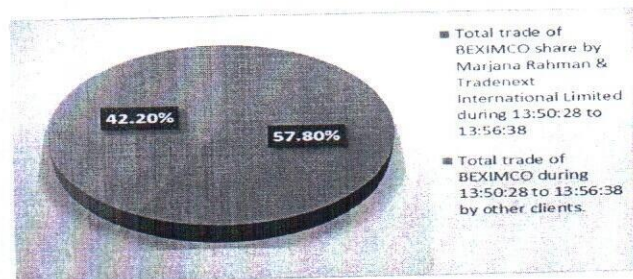

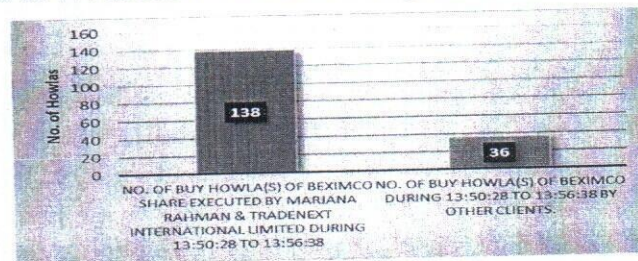

It is observed from the above graphs and screenshot that Marjana Rahman & Tradenext International Limited bought 62.65% of the total trades of BEXIMCO shares by executing 104 of total 120 howlas from 13:02:31 to 13:09:04 on 06-02-2022. From 13:02:31 to 13:09:04, Marjana Rahman & Tradenext International Limited induced the price to rise from Tk. 150.70 to Tk. 151.40. Thus it seems that Marjana Rahman & Tradenext International Limited were actively trying to lift the price of BEXIMCO share.

Again, on that day, Marjana Rahman & Tradenext International Limited started series of trading at 13:50:28 at price Tk. 149.20 and induced the same to rise to Tk. 151.30 up to 13:56:38. It can also be observed from the above graph that Marjana Rahman & Tradenext International Limited executed significant trades during this time period. It is mentionable here that from 13:50:28 to 13:56:38, Marjana Rahman & Tradenext International Limited bought 169,459 shares of BEXIMCO compared to the total traded share of 293,198. This is shown in the following Pie Chart.

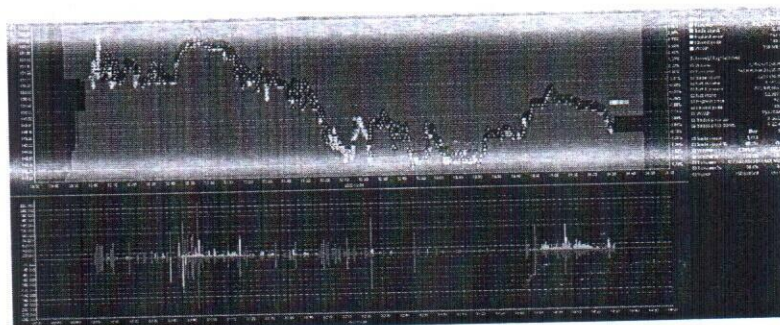

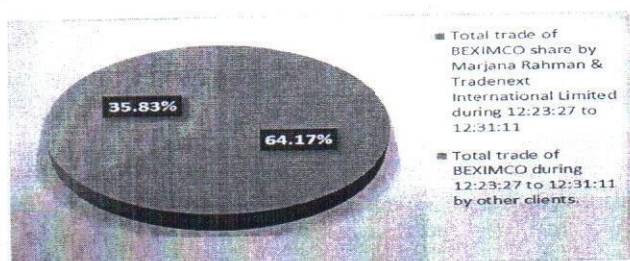

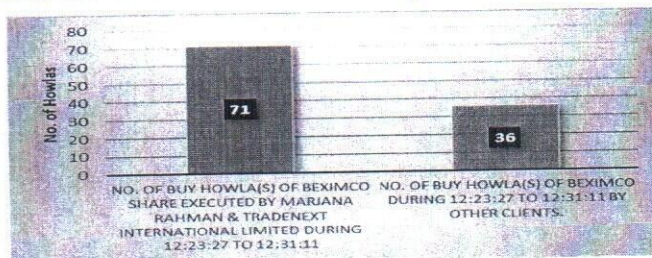

It was observed in the above graph that on 24-02-2022, total number of trades of BEXIMCO in the market was 6711, whereas number of trades (buy) executed by Marjana Rahman & Tradenext International Limited were 3224 which is approximately 48.04% of the total number of trades in the market. Again, total traded volume of BEXIMCO in the market on that day was 5,915,878 whereas buy volume by the said client(s) was 2,043,871 which is approximately 34.55% of the total traded volume in the market. It is evident that the client had significant participation in the market on 24-02-2022 in trading of BEXIMCO share.

On 24-02-2022, trading of BEXIMCO share was started at Tk. 151.00 which is Tk. 0.30 more than the YCP of Tk. 150.70. On that day, Marjana Rahman & Tradenext International Limited started series of trading at 12:23:27 at price Tk. 148.20 and induced the same to rise to Tk. 149.80 up to 12:31:11. It can also be observed from the above graph that Marjana Rahman & Tradenext International Limited executed significant trades during this time period. 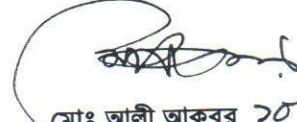
