Subject: Non-Compliance related to not maintaining sufficient fund of customers' in the Consolidated Customers' Account of the Company: Warning to ensure compliance of all securities related laws in future.

This refers to the Commission's show cause cum hearing notice no. BSEC/Enforcement/3733/2024/880 dated 07 November, 2024 based on which the hearing was conducted on 18 November, 2024.

Subsequently, you have submitted your replies vide letter reference no. SSL/Com/BSEC-En/1124/028 dated November 18, 2024 where you mentioned your compliance status.

The Commission, considering your degree of non-compliance, has decided to **warn** you to be careful in future and also suggested to be cautious about maintaining due diligence related to securities related laws. Any divergence of securities related laws and failing of lawful responsibilities will be taken seriously whereas you will be brought under appropriate enforcement action.
